## Seminar on Food Additives and Flavourings

**11-12 May 2010, Zagreb, Croatia**  
Hotel International, Miramarska 24

### DRAFT REPORT

#### **Background information:**

This seminar was organized within the EFSA Pre-Accession Programme 2009/2010 for the Candidate countries and the Potential Candidate countries\* financed by the European Commission under the IPA Component.

The overall objective of the Programme is to promote the understanding of EFSA's work, share expertise and create information exchange mechanisms in order to ensure that the national authorities of the beneficiary countries can participate effectively in the activities of EFSA both prior to accession and following accession to the EU.

The participation in this Programme may contribute to the beneficiaries in familiarising themselves with the EU policies and working methods particularly focusing on "from field to plate" integrated approach to food safety.

#### **Relevance of the Seminar to objectives of the Programme:**

- The seminar provided an overall knowledge on the role of EFSA in the area of risk assessment and risk communication.
- EFSA's role in the risk assessment of food additives, nutrient sources and other substances deliberately added to food were explained by the head of EFSA Unit on food additives and nutrient sources added to food - ANS. The head of EFSA Unit on food contact materials, enzymes, flavourings and processing aids - CEF presented their work related to questions on the safety of use of materials in contact with food, enzymes, flavourings and processing aids, as well as safety of processes.
- In particular, new initiatives in fostering the Pan-European scientific cooperation and harmonisation of risk assessment methodologies was presented. The representatives from the beneficiary countries were encouraged to apply for the EFSA Expert Data Base.
- Experts from the EU Member States and from a Candidate Country presented their approaches in the respected area sharing views on the importance of scientific cooperation particularly when data collection and information exchange is in question.
- This seminar provided a solid starting point for networking and creation of information exchange systems as the first step in preparation of the beneficiaries for their future participation in the EFSA networks.

The audience in this seminar will consist of approximately 50 representatives from the competent authorities in Food Safety from the 3 Candidate countries and 5 Potential Candidate countries.

**Conclusions and recommendations:**

This seminar gave a solid platform for exchange of views and experiences between the representatives from the beneficiary countries, EFSA, the Member States. The participants took an active part in discussions on the different topics related to scientific cooperation and harmonization of risk assessment methodologies when food additives and flavourings are in question.

Representatives from the Candidate countries presented the state of art in the food safety in their countries, explained the structure of the system, and presented the scientific activities and the difficulties they are facing. The contacts established during the seminar together with the gained knowledge will help EFSA in planning the future collaboration with those countries under the Pre-Accession Programme.

The participants were informed about and encouraged to apply to the EFSA Expert Database. The participants were also invited to apply to the EFSA call for expressions of interest for Seconded National Experts within EFSA, particularly to work in EFSA Pesticide Risk Assessment Peer Review Unit.

The contacts established between participants and EFSA representatives and Member States' experts during the seminar will provide a solid starting point for possible future information exchange and collaboration.

**Results of the satisfaction questionnaire**

49 representatives of different competent authorities from the three Candidate countries and the 4 Potential Candidate countries attended the seminar. 40 participants answered to the evaluation questionnaire. Hotel facilities including meeting room were considered as excellent or very good by the majority of the participants (85%). Presentation skills of the speakers (85%), the content of speeches (77%) as well as responsiveness to the questions (70%) were on the highest level. 72,5% of the participants found presentations being on the right level and the majority felt they had enough opportunity to express their opinion and ask questions (80%). The participants considered that this seminar was an excellent or very good opportunity for improving their knowledge on this topic (70%). Additional topics they would like to see addressed in the future seminars include topics such as nutrition and health claims, risk assessment of food enzymes, and antibiotics in food. **27,5%** of participants found the overall value of the seminar as excellent while **62,5%** considered it as very good.
