#### 5.1. Development of Annex I

The WG was presented with the progress on the development of Annex I which will focus on the application of WoE in chemical risk assessment. Two decision trees, one for the human health risk assessment and one for the ecotoxicological risk assessment, were prepared. Also a new shorter version of the introductory part of the annex was presented.

The members of the working group discussed the received inputs and considered those in developing the annex. Overall, the introductory text needed substantial shortening, and the individual examples needed further work. The chairman assigned related tasks to several members and set deadlines for the receipt of their contributions.

#### 5.2. Final discussion on the overall text

The WG discussed some last minor editorial changes on the main text of the guidance. The chairman reminded the WG that the main text had already been updated in light of the comments received during the November SC plenary, and that it was agreed not to amend the text substantially at this point of time.

#### 5.3. Next steps on Annex III

The WG was presented with the progress made on the development of Annex III, which will focus on the case studies to be developed by individual EFSA panels.

As agreed during the previous WG meeting, the Heads of responsible Units in EFSA assigned focal points for each Panel. Each Panel will or already has selected an opinion which has been adopted and which will be used by the focal point in developing a report on their weight of evidence approach applied therein in order to respond to the question identified in their problem formulation.
