1. Introduction to the Communications breakout sessions – by Anne Laure Gassin, Director of Communications	<p>In the Reflection Paper on the engagement of stakeholders' organisations on EFSA's activities, one of the tools proposed in order to increase interaction and enhance the role of the Platform was the request to organise break-out sessions on specific issues. It was decided to start with "communications break out sessions" dealing with scientific issues suggested by the Platform members. The Platform members were invited to express a preference on the subjects to be discussed at the break out sessions and on their attendance. <p>Update on EFSA's Communications activities – by Anne-Laure Gassin, Director of the Communications Directorate</p>	<p>Anne Laure Gassin provided an exhaustive overview of EFSA's recent and upcoming communications.</p> <p>The whole presentation can be found:</p> <p>http://www.efsa.europa.eu/en/events/event/110629.htm</p> <p>Questions and answers (FEFAC; EFFAT, CELCAA) were mainly focused on the E-Coli crisis and on the way EFSA was coordinating the scientific advice to be provided.</p> <p>Anne Laure specified that EFSA was collaborating closely with the EU Member States Authorities, the European Commission and with ECDC.</p> <p>FOODDRINK EUROPE suggested whether it would be possible for EFSA to organise a technical meeting with Stakeholders on the Threshold of Toxicological Concern. BEUC supported such a suggestion.</p>

<p>Outcome of the Stakeholders' Consultative Group on Emerging Risks submitted to EFSA: Report on Stakeholders' activities in the area of emerging risks – by Tobin Robinson, Head of the EFSA Emerging Risks Unit and by Thorsten Guthke from FEFANA and Andreas Varlamos from BEUC, members of the WG.</p>	<p>Tilemachos Goumperis from the EFSA Emerging Risks Unit provided a presentation of the outcome of the stakeholders' consultative Group on emerging risks. The presentation was complemented by Thorsten Guthke, from FEFANA. Tilemachos Goumperis provided the background on the creation of consultative group, the main goals, the main achievements and targets. Thorsten Guthke provided an update on the main outcomes of the report. Tilemachos Goumperis indicated that EFSA is considering having a second mandate for the consultative group renewing the membership and the tasks. A draft mandate will be issued over the summer. It was asked to the Platform members to contribute and input on the second mandate by providing suggestions, inputs and focus of the group to be implemented in the new mandate.</p> <p>The whole presentation can be found at the following link: http://www.efsa.europa.eu/en/events/event/110629.htm</p> <p>Considerations:</p> <p>FEFAC: underlined that in order to increase the efficiency of the group, the group should be integrated with additional scientific expertise, including input from scientific panel members. In addition FEFAC suggested having a chapter on emerging risks in the EFSA annual report.</p> <p>CELCAA underlined that the task of detecting and anticipating emerging risks is extremely difficult, but it is essential to build a robust network of collaboration and communication to be able to respond in the quickest timing and deadline to potential events.</p> <p>EFFAT: suggested that the Agency for health and safety at work has developed a model to detect emerging risks. It was suggested to analyse the model as benchmark.</p>
<p>Recommendations and actions plan stemming from the Reflection Paper on the engagement of the stakeholders in the EFSA's activities – by Dirk Detken, Head of the Legal and Regulatory Affairs</p> <p>2.</p>	<p>Dirk Detken presented the recommendations and actions plan stemming from the discussions on the implementation of the Reflection Paper on the engagement of Stakeholders on the EFSA's activities. He underlined that the document foresees a series of suggestions involving both sides, EFSA and the Stakeholders. As regards the actions to be put in place by EFSA he provided an overview of the next steps and on the deadlines for the implementation. Update on the E-Coli crisis – by Hubert Deluyker, Director Risk Assessment and Scientific Assistance	<p>Hubert Deluyker updated the Platform on the ongoing action taken to face the E-Coli crisis. Hubert Deluyker explained that a rapid risk assessment by EFSA and ECDC, published 29 June 2011, highlighted the links between the French and German outbreaks both associated with sprouts. In both outbreaks the rare strain of E. coli O104:H4 had been confirmed.</p>
