EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

OBJECTIVES

- 
- Attract 'early/mid career' scientists to become risk assessors through learning by doing
 - Build the EU RA capacity and knowledge community
 - Contribute to harmonising risk assessment practices across Europe
 - Further develop EU risk assessment methodologies
 - Intensify exchange and cooperation among national food agencies and EFSA

EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

TARGET AUDIENCE

- 
- Focus of the pilot programme will be on the areas of micro biological and chemical food safety so to attract Scientists (early / mid-career professionals) with the following background:

Molecular Biology, Biology, Microbiology, Biochemistry, Chemistry, Veterinary/Human Medicine or Agronomy/Agricultural Science, Environmental Science, Food Science and Technology, or Toxicology



EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

Fellowship Programme Design (15 fellows)

1. Learning-by-doing and practising through 1 year fellowship placement in a RA competent Authority of a Member State, with high capacity in performing Food Risk Assessment
2. Following a specific and uniform RA training program:
 - one (1) three-week introductory training course at EFSA in *September 2017 and 2018* with availability for 15 additional participants from MS's and EFSA.
 - three (3) specific training modules (only for 15 fellows) one week each distributed during the 1 year programme

EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

FELLOWSHIP CERTIFICATION

- EFSA will provide the fellows with a ***Certificate of Completion***
- ***Network***: The fellows that will complete the programme including the supervisors and the scientific members of the Programme Committee, will become part of the RA Alumni Network set up by EFSA



EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

The Fellowship Programme Committee (1/2)

➤ It's composition:

EFSA:

- Programme Coordinator & Chair
- Scientific Coordinator
- 2 Scientific Programme Committee Members and alternates EFSA

Member States:

- 4 MS Programme Committee Members and alternates from:
Germany – Latvia – UK – Norway

EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

The Fellowship Programme Committee (2/2)

➤ **It's role:**

- Contribute to defining learning objectives, structure and content of the various training modules
- Agree on the proposed tutor's (by future contractor)
- Define Fellow selection criteria
- Agree on 'distribution' of Fellows to the hosting sites
- Liaise with the fellows and supervise the supervisors in each hosting site throughout the entire Fellowship cycle
- Steer the overall program roll out and take action when required

EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

EFSA's offers to:

- Cover, through Procurement, the costs of developing, organising and delivering the fellowship RA training programme
- Cover, through Grant Agreements with MS's, the costs for attracting and 1 year placement of 2x15 scientists

EU RISK ASSESSMENT FELLOWSHIP PROGRAMME OUTLINE

Tentative Calendar of Major Milestones

- **Jan '16** => composition programme committee
- **Jan '16** => identification training hosting sites
- **Jan – March '16** => drafting procurement specifications training
- **April – Sept '16** => running procurement procedure and contract award
- **Sept onwards** => closely monitor contract execution
- **Oct '16 – March '17** => running fellow call for expression of interest
- **March '17** => selecting 15 fellows
- **March – April '17** => assignment of fellows to hosting sites
- **May '17** => signature of grant agreements with hosting sites
- **June '17** => workshop with all involved (committee, contractor, tutors,...)
- **Sept '17** => roll out of first fellowship exchange cycle 12 months
- **Sept '18** => roll out of second fellowship exchange cycle
- **Nov '18** => issuing an evaluation report on lessons learned 1st cycle
- **Nov '19** => issuing a final evaluation report on entire 2 yrs. pilot
