Valeriu Curtui chaired the meeting until the chair of the Panel was elected.

## **4. Declarations of Interest of Scientific Panel Members**

In accordance with EFSA's Policy on Independence<sup>2</sup> and the Decision of the Executive Director on Competing Interest Management,<sup>3</sup> EFSA screened the Annual Declarations of Interest filled out by the Panel members invited to the present meeting. Prof Androniki Naska and Prof Harry McArdle were elected as vice-chairs. The newly-elected chair then took over as Chair of the meeting for the remaining items (6-11).

## **6. Introduction to the EFSA and NDA Panel working practice**

Valeriu Curtui introduced to members the working practice of EFSA and the Panel including the framework and procedures in place. The NDA mission and the areas of mandate covered were presented. The role of the Nutrition Unit, the NDA Panel and the Working Groups (WG), and the Rapporteur(s) were outlined. Responsibilities and key values for appointed members were highlighted.

The EFSA procedure for setting scientific working groups<sup>4</sup> was also explained.

## **7. Introduction to work programme of NDA Panel**

The work programme of the NDA Panel for the next three years and the main activities were described. In particular, the Panel was given an overview of the mandates covered for the following working groups, and relevant regulatory framework/the principle applied, the workflow, the status and timelines were outlined:

- Novel Foods (including Traditional Foods from Third Countries)
- Nutrient sources and other substances with physiological effect added to foods
- Health claims
- Dietary Reference Values
- Sugars
- Food for specific groups
- Food Allergens

## **8. Confirmation of on-going Working Groups and/or setting new Working Groups**

The Panel confirmed the need for the following existing Working Groups in order to assist the Panel in undertaking all necessary preparatory tasks in relation to draft scientific outputs falling under its remit, i.e.:

- Working Group on Novel Foods, with an update to include Nutrient Sources;

- Working Group on Claims;
- Working Group on Dietary Reference Values for Minerals
- Working Group on Infant Nutrition
- Working Group on Sugars

The Panel agreed with the closing of:

- Working Group on Food Allergy;
- Working Group on Dietary Reference Values for Vitamins.

## **9. Appointment/confirmation of Working Group Chairs**

Chairs of WGs will be appointed by the Panel Chair, in consultation with Nutrition Unit and in accordance with EFSA procedure for establishing, updating and closing a scientific Working Group.

### **Interests and actions resulting from the Oral Declarations of Interest done at the beginning of the meeting**

**NO CONFLICT:** With regard to this meeting Prof. Stefaan De Henauw declared the following interest: participation to a half-day “expert roundtable” on 7th June 2018, which was organised by Pain & Sante (Belgium) as one of the Work Packages under the framework of an EU funded project. The topic of the discussion was on public health aspects of bread in a National Nutrition and Public Health Policy. Promotional aspects of bread consumption were not within the scope of the expert round table<sup>5</sup>. In accordance with EFSA’s Policy on Independence<sup>6</sup> and the Decision of the Executive Director on Competing Interest Management<sup>7</sup>, and taking into account the specific matters discussed at the meeting in question, the interest above was not deemed to represent a Conflict of Interest for the expert concerned.
