2. ADOPTION OF THE AGENDA

The agenda was adopted.

3. DECLARATIONS OF INTEREST

EFSA secretariat screened the ADoI and SDoI filled in by the scientific experts invited at this meeting in accordance with EFSA's Policy on Declarations of Interests.

With regard to the ADoI, SDoI and this meeting no other interest than those already declared in the ADoI or in a previous SDoI and screened by EFSA in accordance with its Policy on Declarations of Interests and implementing documents thereof was declared by the experts.

4. ROUND TABLE PRESENTATION OF PANEL MEMBERS AND OF SECRETARIAT

All BIOHAZ Panel members and EFSA staff introduced her/him self in turn.

5. PRESENTATION OF EFSA

A series of general introductory presentations were made giving an overview of the different departments and their responsibilities within EFSA: a) Introduction to the Risk Assessment Directorate and the scientific work of EFSA b) Introduction to the Scientific Committee and Advisory Forum. c) Introduction to the Scientific Cooperation and

Assistance Directorate. d) Communication strategy of EFSA. e) Legal aspects / Declarations of Interest and f) Financial aspects

6. ELECTION OF PANEL CHAIR AND VICE CHAIRS

The election of a chair person and two vice chairs took place following the procedure as established by EFSA. Prof. John Daniel Collins was elected unanimously as Chair. Prof Budka and Dr. Birgit Noerrung were also elected unanimously as vice chairs. As from then the newly elected chair took over from Dr. Hugas as chair.

7. ROLE AND ACTIVITIES OF THE BIOHAZ PANEL.

The Head of the BIOHAZ unit gave a presentation on the mandate and remit of the BIOHAZ panel and the organisation of the work related to meetings and delivering of opinions.

8. MANDATES IN PROGRESS FOR BIOHAZ PANEL

An overview was presented of the on-going mandates in the area of BIOHAZ. Five areas were distinguished: BSE/TSE, Food Borne Zoonoses, Food Hygiene, Animal By Products as well as food safety implications from welfare issues.

9. NEW MANDATES RECEIVED FROM EC

Three new mandates were allocated to BIOHAZ by EFSA.

9.1. REQUEST FOR TECHNICAL ASSISTANCE RELETED TO THE EFSA OPINION ON TRANSFORMATION OF ANIMAL BY-PRODUCTS INTO BIOGAS AND COMPOST

A request from the European Commission (EC) was received asking for technical assistance related to the previous EFSA opinion on the safety vis -à-vis biological risks of biogas and compost treatment standards of animal by-products (EFSA-Q-2003-097). The Panel decided to establish an “*ad hoc*” Working Group. An extension of the deadline will be requested for end of December 2009.

9.2. TECHNICAL ADVICE ON A PROTOCOL FOR ADDITIONAL DATA COLLECTION BASED ON THE EFSA RECOMMENDATIONS ABOUT RESISTANCE TO SCRAPIE IN GOATS IN CYPRUS.

Request from the EC for a technical advice on a protocol for additional data collection, prepared by the TSE CRL (Community Reference Laboratory) following a request from DG SANCO and based on the EFSA recommendations of the Scientific Opinion of the Panel on Biological Hazards on genetic TSE resistance in goats in Cyprus. A working group is to be established. Deadline July 2009.

9.3. TSE RAPID TESTS SENSITIVITY.

A mandate was received from the EC to provide a scientific evaluation of a study carried out by the CRL for TSE on the assessment of the analytical sensitivity of current approved rapid TSE tests for ruminants. The deadline given is 1 September 2009. The Panel recommended to extent the deadline to December 2009 due to the workload.
