



Adopted in March 2020 by MB 1. Public Access to Documents Published on EFSA website (Reg. 178/2002, Art. 41) 2. Pre-submission advice and Public Consultation (Reg. 178/2002, Art. 32a, b, c) 3. Transparency and Confidentiality Adopted in December 2020 by ED Assessment by EFSA Published on EFSA website (Reg. 178/2002, Art. 38 and 39d(5) 4. EFSA completed the revision of 27 guidance documents (GDs): ✓12 administrative and 15 scientific GDs

Concluding activities:

- Formal consultation of 4 administrative GDs (smoke flavourings and 3 food contact materials) with the College of Commissioners is finalized, comments addressed
- Pesticide GD was consulted with PAFF committee, comments under finalization

Publication of all GDs in EFSA Journal by 27th March

In all cases, security and confidentiality are key aspects of the new technology, and compared to today's systems a higher level of automation to ensure respect for deadlines and including auditability, dual factor authentication, monitoring and logging



- 54 organisations from 29 Countries have been identified as needing VPN access to Agency IUCLID
- 29 Organisations have accepted a solution and 23 have an implementation plan
- 8 are identifying the most suitable solution





Hypercare

 - IUCLID workflow integration for confidentiality assessment of Pesticides dossiers
- Preparation for the new Management Board in 2022
- Preparation for new Scientific panels
