



Contractual definition

Operational definition

- Modality agreement
- Staff training/exchange
- Dossier evaluation trial



Modality:

Dedicated consultation of MS via nominated experts

Steps:

- \checkmark AF members express interest to participate (by 20.11.2020),
- Very positive \checkmark Interested MS nominates one scientist per country (by 20.12.2020),
- \checkmark EFSA consults the MS experts via a dedicated technical meeting (11 & 15.01.2021),
- Draft guidance go to public consultation (March May 2021),
- \Box MS experts will be invited to the stakeholder events (June 2021),
- Guidance adoption (Sept or Nov 2021)
- □ EFSA will invite experts from this group, upon needs, to join the ENZ working group.

Long-term objective:

□ Partnership between EFSA and MSs for EU-wide RA capacity to meet the demand of innovation

Partnership model on novel foods: recap



- Organisations from one Member state or a consortium from more Member States put together the necessary expertise to carry out the draft assessment
- One organisation acts as coordinator
- Financial compensation by EFSA through dedicated grant (^cofinancing)
- Collaboration with EFSA along the risk assessment process
- Assessment in line with EFSA guidance documents, DoI management, confidentiality and IT security
- NDA Panel finalises and adopts the opinion
- Contributors will appear as authors in the final output



 Following presentation to the AF meeting and to the Novel foods Network meeting EFSA received five expression of interests

Croatia, France, Germany, Greece and Spain

 EFSA will start consultation with the interested parties to co-design a proposal for partnership model

[March-June 2021]

- Launch of call for partnering grant [summer 2021, tbc]
 - Open to all member states
