7.3.1 CEP WG on Extraction Solvents

The CEP Panel was informed about the establishment of a new working group on extraction solvents for assessing the safety of extraction solvents used in the production of foodstuffs and food ingredients that are regulated under Directive 2009/32/EC, following the receipt of a new request (EFSA-Q-2021-00010). Claude Lambré has been appointed as chair of the WG.

7.3.2 Withdrawal of the adoption of draft opinion "safety assessment of Food enzyme isomaltulose synthase from *Protaminobacter rubrum* (Z12A)" (EFSA-Q-2015-00620)

At the 18th CEP Plenary meeting held in January 2021, the CEP Panel adopted the scientific opinion on the safety assessment of Food enzyme isomaltulose synthase from *Protaminobacter rubrum* (Z12A) (EFSA-Q-2015-00620). During the pre-notification phase previous to publication, EFSA became aware of some technical inaccuracies affecting different sections of the opinion. In accordance with the applicable EFSA SOP 12, the publication of the adopted scientific opinion was put on hold. The CEP Panel decided to withdraw the adoption. The opinion will go back to the WG to be revised.
