
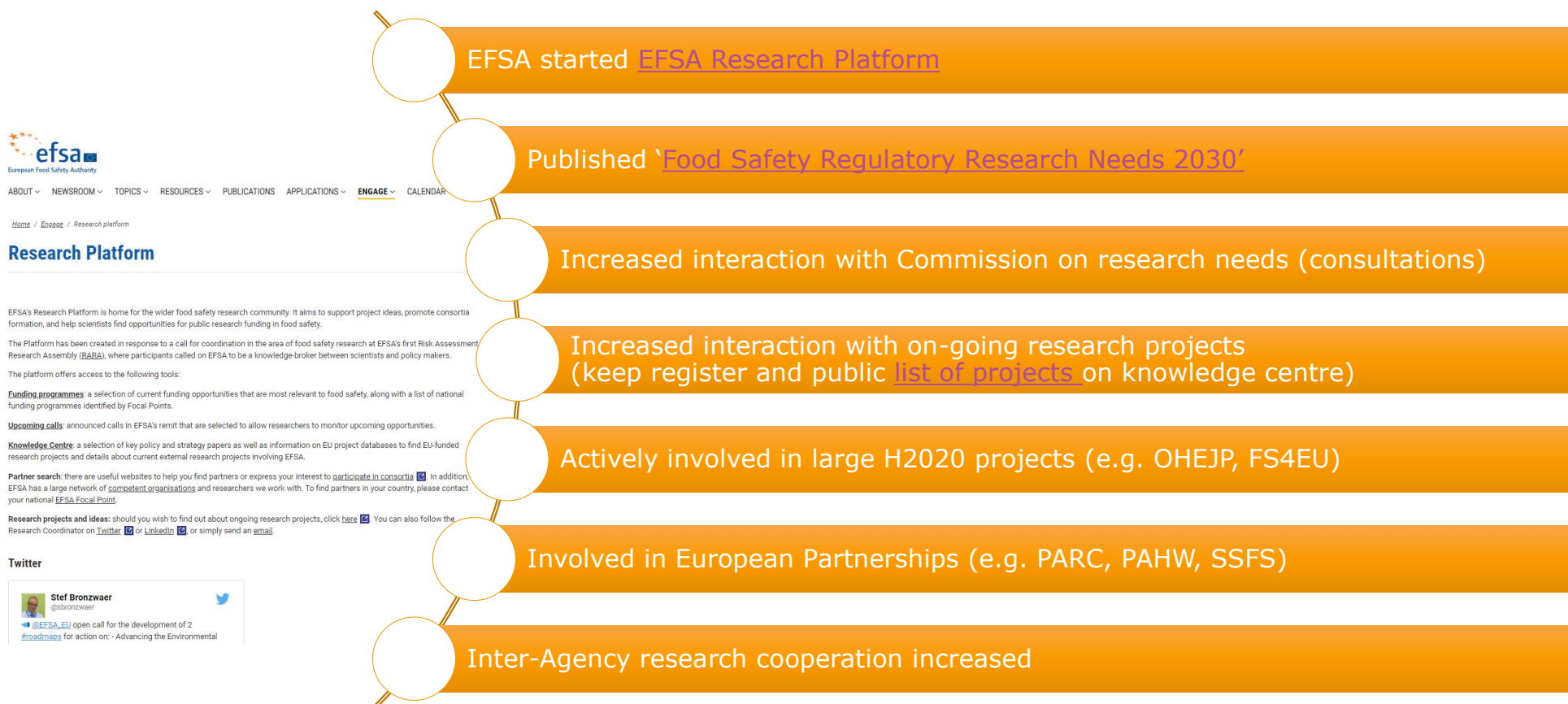

Vision for RARA22 – Broaden³ & Bridge

- Broaden knowledge-broker role to MS / national food agencies
- Broaden narrative from food safety centric to food safety in support of safe and sustainable food systems (i.e. support SDGs & Green Deal)
- Broaden participation
- Bridge - RARA has bridge function:
 - Science & policy (=regulatory science)
 - MS authorities. EFSA shares broker-function with Focal Points / national food agencies
 - EU and national (and regional) research funding. H2020 evaluation found lack of synergy
 - different scientific disciplines in the food chain (beyond traditional food safety actors to food system actors)

Objectives of RARA22

- 1. Build greater understanding** and promote synergies to enable research outputs to **support the achievement of the SDGs and relevant European policies**, including the Green Deal.
- 2. Foster alignment of R&I investments** to deliver research outputs that inform regulatory science and future policies at European, regional and national level.
- 3. Networking and relationship building** in the wider food safety risk assessment ecosystem.

Postponed

- Ongoing limitations from COVID include:
 - Social distancing
 - Travel restrictions
 - Travel budgets freeze
- Postponed to **7 December 2022** in Berlin
 - Networking activities possible
 - Opportunity to reflect on ONE conference (June 2022)
 - Programme & speakers foreseen to remain similar
 - Programme Committee to resume planning in Q1 2022
