
- <u>Tool</u> to extract data from IUCLID and present it in report (PDF, RTF) or machine-readable format (XML, CSV)
 - Based on report templates (.ftl) & stylesheets (.xsl)
 - Modular approach: re-usability across reports
- Available reports added and updated in IUCLID releases
 - Templates also published in <u>Zenodo KJ</u>, which can be uploaded in report manager

How to access and run Report Generator



From a dataset or a dossier:

- select 'Generate report' under the 3-dot menu
- select required type of report and output format

For applicants:

 \rightarrow Summaries of the different sections of the PPP dossier used to prepare DAR/RAR

→ToC as close as possible to requirements in legislation (EU Reg 283/2013 & 284/2013)

- not necessarily the same as in IUCLID!
- based on selected endpoint and/or other fields see the crosswalks

→ Studies structured as in Appendix E of the administrative guidance

 \rightarrow Incl. intended (D1, D3) and authorised (D2) uses

Available reports for PPP



For evaluators:

- NoS Extraction Request [PDF, RTF, CSV]
 - → Summary of all the studies included in the application together with:
 - Notification of Studies (NoS) IDs or justification for not providing them
 - relevant information e.g. endpoint, GLP, test facility, test period...
 - \rightarrow To be used by RMS to cross-check with EFSA's Notification of Studies database
- Confidentiality Report for PPP [PDF, RTF]
 - \rightarrow List of confidentiality claims made by the applicant for assessment by RMS
 - \rightarrow (on-going) To be harmonised with a cross-domain Confidentiality Report



- Reports developed by ECHA also applicable to PPP applications:
 - Literature references report [RTF, CSV]
 - Substitute of the Documents L, only one document for all sections
 - CSV version allows filtering for specific IUCLID sections e.g. physchem, tox...
 - confidential fields in vertebrate studies hidden if run from the filtered dossier as per the filter rules
 - List of annotations [PDF, RTF]
 - List of attachments [RTF, CSV]

Documents N	N1 – Overall Conclusions	summary documents in IUCLID
	N2 – List of Endpoints	 key values for chemical safety assessment from summary documents (not always available)
	N3 – Substance & Metabolites	 reference substance info in metabolites documents + inbound references (difficulty in extracting levels in matrices/compartments)
	N4 – Metabolites in Groundwater	existing document in IUCLID
	N5 – Isomeric Composition	missing document?



Report	Description & remarks
Assessment from other authorities	 related to backlog item 2064 compilation of all information on MRLs in one table
Study comparison	 table comparing main results from all studies of same/similar endpoints
Data waivers	 list of all the data waivers in a dossier

General remarks & discussion



- all data in a IUCLID dataset can be used, processed & presented in different formats with Report Generator
 - exception: rich-text fields (only possible to present as such) & attached docs
 - Iimitations:
 - not possible to combine data from different datasets/dossiers
 - not possible to (pre-)select documents to be used by the tool
 - complex error-handling / bug-fixing in web interface
