With regards to the EP Mandate, the WG agreed on the latest version of the draft protocol⁵, updated to comply with the requests of the BIOHAZ Panel reviewers. This draft protocol version will be presented for approval to the next BIOHAZ Plenary (16-17 March). Contributions provided by the WG members to the different sections of the draft scientific opinion, considering the three main food-producing animal species broilers, pigs and cattle, were discussed. During this meeting, the main discussions focused on the section on risk factors (term of reference 2) and its reorganization. Contributions received for the mitigation options section and introduction were also discussed. The

4. Introduction to the EFSA Process, WG membership, administrative issues and the digital collaboration platform

EFSA introduced the process for delivering scientific opinions, the role of the WG members and provided information on administrative issues for the experts.

EFSA also introduced the digital collaborative platform which will be used for communication, coauthoring documents, and sharing relevant literature and supporting materials.

5. Scientific topic(s) for discussion

5.1. Transmission of antimicrobial resistance (AMR) during animal transports the food chain⁴

The Mandate was received from the European Parliament and was allocated to the EFSA BIOHAZ Panel. The work will be done in close collaboration with the EFSA AHAW Panel which is currently working on a parallel EC Mandate concerning the protection of terrestrial animals during transport (focus on welfare). The BIOHAZ scientific opinion shall be adopted by 30 September 2020. The development of the opinion will be closely followed by the European Commission as an observer.

During the meeting, the background and Terms of Reference (ToR) of the Mandate were presented. The chair of the WG and EFSA secretariat in charge of the Mandate (BIOCONTAM Unit) provided additional background information. EFSA Secretariat from the ALPHA Unit presented the parallel AHAW

Mandate and discussions followed this presentation. The need to develop a protocol and perform uncertainty assessment according to the "EFSA Technical Report Draft framework" for protocol development for EFSA's scientific assessments⁵ and "EFSA Scientific Committee's Guidance on Uncertainty Analysis in Scientific Assessments"⁶, respectively, was indicated. The WG initiated the discussion on the interpretation of the ToRs, which were clarified by the WG chair and EFSA staff and will continue with this discussion to agree on a common understanding in the next meeting. The preliminary table of contents was presented, and the structure and main sections were agreed. EFSA Secretariat presented the steps needed to produce the draft protocol for the current assessment and provided an example to be further developed by the WG. Literature searches already performed by EFSA Secretariat and structure of the literature repository were presented. WG experts were appointed to further develop each of the sections of the draft opinion, section leaders were identified, and tasks were allocated.

Alternatives for the dates of the 2022 WG meetings were shared with the WG and feedback from the experts will be provided to EFSA Secretariat after the meeting.

6. Next meetings

The second meeting of the ad hoc WG is 20 December (Web-meeting). The dates for the planned 2022 meetings will be agreed in the next weeks.
