## Feedback from EFSA

Trusted science for safe food

- The EFSA Administrative Guidance on submission of dossiers and assessment reports for the peer-review of pesticide active substances and on the maximum residue level (MRL) application procedure is under revision.
- Consultation of the MSs/EC is planned between End January – Mid February. The plan is to present it at the PAFF meeting for note taking at the end of March 2023. The admissibility checklist recently finalized will be included in the Guidance.
- This update takes account of new features included in recent IUCLID releases and updates based on experience gained from evaluations of IUCLID dossiers (including the use of report generator).

- Problems have been identified with one of the VPN tunnels – EFSA IT experts are analysing the problem and there was maintenance work on Sunday
- When logging in to Agency IUCLID remember to login as a foreign user and make sure the URL is the correct one (I.e., <https://ecs-efsa.echa.europa.eu/cloud/home.html>)
- If you are having problems accessing Agency IUCLID please raise a ticket with AskAQuestion - do not contact ECHA, we will liaise with them if needed
- Please include the contact details for your organisations IT/Network expert to facilitate further investigations

- EFSA is starting a round of bilateral meetings with Rapporteur Member States giving the opportunity to discuss most relevant issues and challenges encountered during evaluation of post transparency applications.
- This includes issues with IUCLID, admissibility check, technical IT issues.
- We have had the first meeting with AT during the last week of November. The aim is to reach other MSs in the coming month.
