lifespan of the mandate; c) uncertainty and protocol development guidance documents to be followed and d) the work plan, meetings planned and technical and scientific support provided by EFSA. EFSA staff in charge of the EFSA 2010 scientific opinion⁴, presented the main findings, conclusions and recommendations of the document. The chair of the WG presented the background and Terms of Reference (ToR) of the EC mandate from the BIOHAZ Panel to the WG and clarifications of the ToRs were done. Main findings of the ParaFishControl project were presented to the WG by a member involved in the project.
