## How to raise awareness of opportunities :

- Make **materials** and **guidance** more easily available
- More **national events** to onboard **Art 36 organizations**
- Increase understanding on **subcontracting** and on national mechanisms **to acquire resources** to support FP work
- Share **best practices** and **learn by doing**
- Share **results, benefits, success stories** from tailor-made activities



# OUTCOME OF DISCUSSION: OPPORTUNITIES (2/2)

## An all-inclusive approach

- Promote interlinks between **AF, FP and MB**
- Take into consideration different **MS contexts** and **administrative challenges**
- Promote **geographically and region-oriented** collaborative activities
- Stimulate **cross-country consortia**
- Visibility of **IPA III action** + include IPA countries in **FP tailor-made activities**

## Other issues raised

- **Transparent assessment** of tailor-made proposals – through *monitoring tool*
- Regular / ad-hoc **meetings on tailor-made activities** – to assist *planning*
- Expand **access rights** to Focal Point **microsite** – *under consideration*
- Increase number of Focal Point **physical meetings** – *under consideration*
