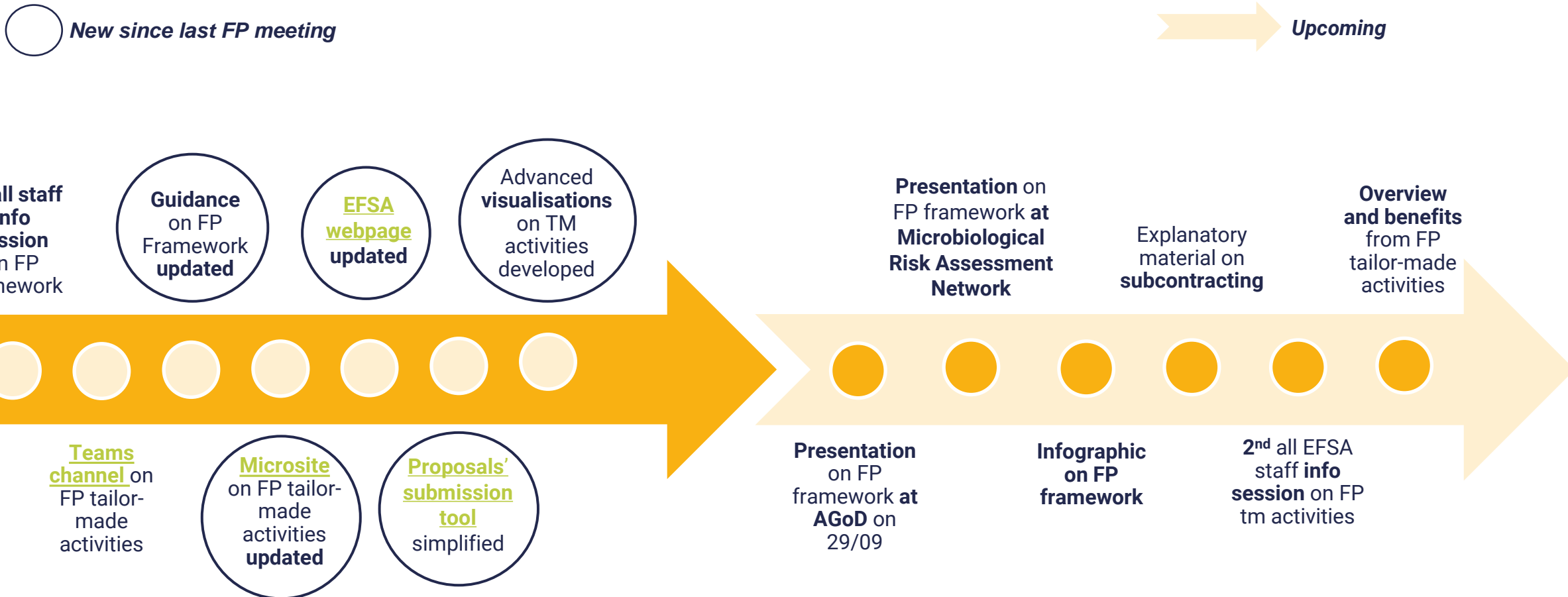
ACTION POINTS FROM 51ST FP MEETING, 24-25 MAY, 2023

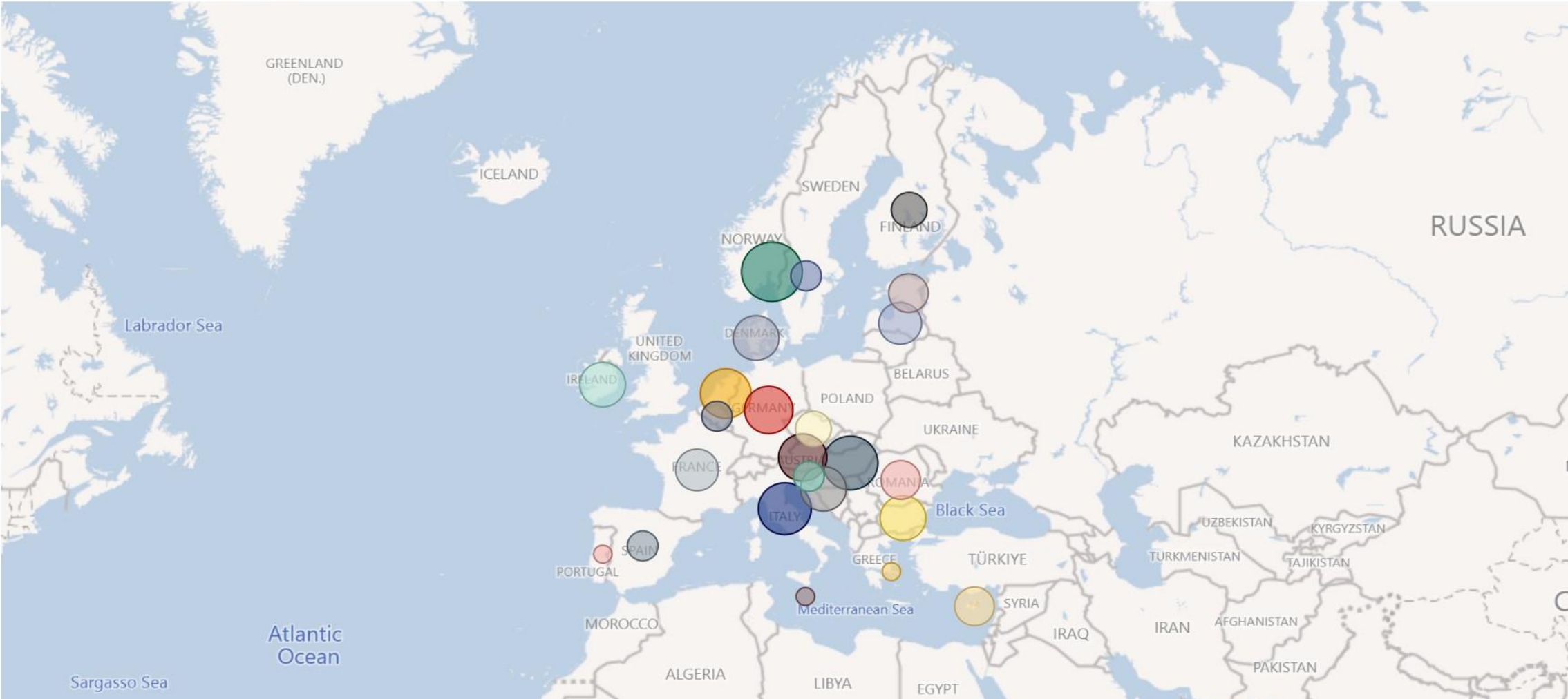
