The minutes of the 1st Working Group meeting were agreed by written procedure on 13 February 2023.

V. Definition of the steps till the adoption of the SO

A definition of the steps and the way of working until the adoption of the Scientific Opinion (SO) was made by the EFSA staff.

VI. Eligibility criteria of EFSA's guidelines (ToR 1)

a. Description of the method including potential sources of pain, distress and suffering

The Working Group (WG) discussed about the description of the stunning method, including potential sources of pain, distress and suffering, and reviewed the text that had already been prepared by the Tasking Grant (TG) group on this. They agreed that some important information is still missing from the updated dossier submitted by the applicant.

b. Key parameters of the effective use of the method for poultry and pigs

The WG discussed about the key parameters of the effective use of the method both for poultry and pigs and in particular reviewed the text of the TG group and agreed on the information that is still missing from the updated dossier.

c. Scientific basis of induction and maintenance of unconsciousness for this method

The WG discussed and reviewed the text of the TG group already prepared regarding the scientific basis of induction and maintenance of unconsciousness for this method.

d. Potential causes of system failure and chances of occurrence

1. For poultry

The WG checked the text of the TG group about the potential causes of system failure and chances of occurrence for poultry. Overall, they considered that additional information is still needed from the applicant in order to proceed with the scientific assessment of this method. Therefore, another request for additional information will be sent to the applicant and agreed on the format of the document to be sent.

2. For pigs

The WG reviewed the text of the TG group about the potential causes of system failure and chances of occurrence for pigs and overall, they considered that additional information is still needed from the applicant in order to proceed with the scientific assessment of this method. Therefore, another

request for additional information will be sent to the applicant and agreed on the format of the document to be sent.

VII. Tasks and deadlines

EFSA will clear the document, prepared by the TG group, from the comments made by the WG before and during the meeting and will refine the text regarding the descriptive part submitted by the applicant until the end of July. Specific tasks were also delegated to the WG group members, i.e.: to refine the text prepared by the TG group regarding the assessment on the scientific basis of induction and maintenance of unconsciousness for this method as well as on the potential causes of system failure and chances of occurrence for poultry and pigs, based on the comments until 21 August 2023, and to draft the specific questions in order to request additional information from the applicant. This questionnaire will be sent by EFSA to the WG for their final approval until 19 July 2023.

VIII. Any Other Business

The Chair of the WG proposed to discuss if EEG data of this method is necessary to prove equivalence with the actual gas methods. EFSA staff provided the relative information of EFSA Guidance that is:

- The extent of disruption caused by a stunning method and the induction of unconsciousness and insensibility are best demonstrated by recording electrical activity of the brain using EEGs (EFSA, 2004).
- To assess the onset of unconsciousness and death and the magnitude of pain, distress and suffering, ABMs should be used. These measures can be (i) neurological (e.g. EEG records), (ii) physiological (e.g. heart rate variability), (iii) behavioural (e.g. escape attempts) or (iv) physical reflexes (e.g. tonic-clonic seizures).

Therefore, the WG agreed that EEG data is best to be provided but it is not mandatory.

IX. Next meeting

The next WG meeting will be held on 04 September 2023 via web conference.

The WG checked the completeness of the description of the new stunning method as presented in the technical document submitted by the applicant and in relation to the prepared document of the TG group. In particular, they reviewed and agreed on the information missing regarding: the name of the method, the description of the method itself, the key parameters of the effective use of the method, the scientific basis of induction and maintenance of unconsciousness for this method and the potential causes of system failure and chances of occurrence. Simultaneously, some questions were formed about the document that would be sent to the applicant for providing them additional information.

d. Description of the individual studies submitted

The WG checked the completeness of the individual studies submitted for stunning and killing poultry and pigs and reviewed and agreed on the missing information from the applicant as described in the previously mentioned prepared document, while at the same time a few questions were formed for the applicant.

Simultaneously, a few questions were formed for the applicant. They concluded on the overall completeness of the application submitted and on the revision of the whole document prepared by the TG group. The WG considered that additional information is needed from the applicant in order to proceed with the scientific assessment of this method. Therefore, a request for additional information will be sent to the applicant and agreed on the format of the document to be sent.

EFSA will clear the document, prepared by the TG group, from the comments made by the WG before and during the meeting, regarding the check for completeness of the method submitted. EFSA will also prepare a separate document with specific questions in order to request additional information from the applicant. Both of the documents will be sent to the WG in the beginning of February 2023 for their final approval.
