4. Agreement of the minutes of the 138th CONTAM Panel Plenary meeting held on 30-31 January 2024, teleconference

The minutes of the 138th Panel plenary meeting were agreed by written procedure on 14 February 2024.

5. Report on written procedure

In agreement with the Panel Chair, Kevin Chipman has been nominated as Chair of the WG on perchlorate, which will work on an updated scientific Opinion on the risks for human health related to the presence of perchlorate in food.

6. Scientific output(s) submitted for discussion/adoption

6.1 Draft Opinion on small organoarsenic species in food. (<u>EFSA-Q-2021-00496</u>)

The Chair of the WG on Arsenic presented the draft Opinion on small organoarsenic species in food for discussion and possible endorsement of selected sections. The Panel went through the section on Derivation of reference points and approach to risk assessment and Risk characterisation, and endorsed these sections pending agreed updates. The Panel also discussed the sections on Occurrence data submitted to EFSA and Exposure assessment, and the way to express the occurrence data submitted to EFSA. The structure and content of the section on Uncertainty analysis was discussed and agreed. The WG will take into consideration the feedback received and will continue with the development of the draft Opinion.

6.2 Draft Opinion on the update of tetrabromobisphenol A (TBBPA) and its derivatives in food. (EFSA-Q-2018-00434)

The Chair of the WG on BFRs in food presented the draft Opinion on the update of the risk assessment of TBBPA and its derivatives in food for discussion and possible endorsement of selected sections. The CONTAM Panel members went through the pending sections under Toxicity in experimental animals (Immunotoxicity, Neurotoxicity/neurobehavioural effects, Genotoxicity, Carcinogenicity) as well as through the sections on Observations in humans, Mode of action, Consideration of critical effects, Dose-response analysis, Approach for risk charcatrisation and Risk characerisation. The Panel provided comments to the draft sections presented and endorsed these sections. The WG will take into consideration the feedback received and will continue with the development of the draft Opinion.

7. Any other business

The members were informed on the recent public consultations launched by the EFSA Scientific Committee on the 'Draft Guidance on Risk-Benefit Assessment of Foods, Update' 6 and on the 'Draft Guidance on appraising and integrating evidence from epidemiological studies for use in EFSA's scientific assessments' 7 .
