1. Welcome and apologies for absence

5. Scientific outputs submitted for discussion

5.1 Scientific opinion on new developments in biotechnology applied to microorganisms EFSA-Q-2023-00050

At the 161st Plenary meeting of the GMO Panel, the draft opinion on new developments in biotechnology applied to microorganisms was endorsed and a public consultation launched.⁴ The consultation was closed 8/4/24 and about four hundred comments were received. The assessment of the comments is taking place in the GMM-NGT WG⁵. The GMO Panel revised the updated draft opinion. The opinion will be further revised by the GMM-NGT WG and the draft opinion will be presented at the next GMO Plenary for discussion and possible adoption.

5.2 European Parliament's request for a scientific opinion on recent studies on the proposal for a regulation of the European Parliament and the Council on plants obtained by certain NGT and their food and feed and amending regulation (EU) 2017/625 EFSA-Q-2024-00178

The European Parliament on 22 February 2024 requested EFSA in accordance with Article 29 of Regulation 178/2002, to deliver a scientific opinion on the analysis by ANSES on Annex 16 of the EC proposal for a regulation on plants obtained by certain NGTs and their food and feed and amending Reg (EU) 2017/625.

The GMO Panel was informed that the activity on the mandate is progressing by the cross cutting WG.7 The structure and the methodology followed by the WG were introduced and a first draft of the opinion presented. The GMO Panel revised the draft opinion. The opinion will be presented at the next GMO Plenary for discussion and possible adoption.

5.3 Update on the self-task mandate of the GMO Panel on a scientific opinion regarding protein safety assessment EFSA-Q-2023-00664

EFSA informed the GMO Panel on the progresses made on the self-task mandate of the GMO panel on a scientific opinion regarding protein safety. It was presented and discussed the current proposal on how to structure the opinion and the foreseen new timelines due to a postponement of the activities. It is expected to endorse the scientific opinion and launch the public consultation at the end of 2024. The final adoption of the scientific opinion estimated to happen by mid-2025. Further discussion is needed.

8.2 EFSA 2023-2024 Expert Feedback Survey

In December 2023 the experts of the EFSA Scientific Panels and of the Scientific committee were invited to fill a survey. The questions investigate the scientific and organisational support provided by EFSA and the expert's engagement in working with EFSA. The main findings of the survey, as well as the specific results for the GMO Panel were presented and discussed. The results of the survey will be used as input for lesson learnt and follow-up actions for the new Panel 2024-2029.
