6. Scientific output(s) submitted for discussion/adoption

6.1 Draft Opinion on small organoarsenic species in food (EFSA-Q-2021-00496)

The Chair of the WG on Arsenic presented the comments received during the Public Consultation together with the draft responses to these by the WG. The CONTAM Panel agreed with the responses, and proposed some refinements to be made.

6.2 Draft Opinion on the update of the risk assesment on tetrabromobisphenol A (TBBPA) and its derivatives in food (EFSA-Q-2018-00434)

The Chair of the WG on BFRs in food presented the comments received during the Public Consultation. The CONTAM Panel discussed and made some suggestions on the lines to address the comments.

6.3 Draft Opinion on the update of the risk assessment on brominated phenols and their derivatives in food (EFSA-Q-2018-00436)

The Chair of the WG on BFRs in food presented the draft Opinion on the update of the risk assessment of brominated phenols and their derivatives in food for discussion of selected sections. The CONTAM Panel members went through the sections on Toxicity in experimental animals, Consideration of critical effects, Dose-response assessment and Approach for risk characterisation. The Panel provided comments to these draft sections and agreed on the approach for risk characterisation that will be taken into consideration by the WG to continue with the development of the draft Opinion.
