## 4. Agreement of the minutes of the 147<sup>th</sup> CONTAM Panel Plenary meeting held on 12-14 November 2024, Parma

## 6. Scientific output(s) submitted for discussion/adoption

### 6.1 Draft Opinion on the update of the Opinion on perchlorate in food ([EFSA-Q-2024-00168](#))

The Chair of the WG on Perchlorate and the responsible Scientific Officer presented the draft Opinion on the updated assessment of the risk to human health related to the presence of perchlorate in food, for possible endorsement for public consultation. The CONTAM Panel went through the new sections presented, i.e. Risk of bias assessment, Derivation of a HBGV, Occurrence data, Dietary exposure assessment, Reported non-dietary sources of exposure, Risk characterisation, Uncertainty analysis, Conclusions, Recommendations, Abstract and Summary. The Panel also went through the changes introduced to address comments made at previous meetings and agreed to them. The Panel endorsed the draft Opinion for public consultation, taking into consideration the changes requested by the Panel during the meeting.

## 7. Updates on new mandates

### 7.1 Final mandates received

The CONTAM Panel received two new mandates as described below (more information available at <https://open.efsa.europa.eu>):

- Request for a Scientific Opinion on the risks for human health related to the presence of **semicarbazide (SEM) in food** ([EFSA-Q-2024-00581](#) / [M-2024-00098](#)).
- Request for a Scientific Opinion on the safety of smoked meat and smoked meat products, smoked fish and smoked fishery products and smoked cheese and smoked dairy products following the use of **conventional smoking processes** ([EFSA-Q-2024-00692](#) / [M-2024-00091](#)).
