## **6. Scientific output(s) submitted for discussion/adoption**

### **6.1 Application for the authorisation of pea fibre concentrate (FIPEA) as a new food additive (EFSA-Q-2022-00795)**

### **6.2 Re-evaluation of pullulan (E 1204) (EFSA-Q-2021-00278) and scientific opinion on the proposed extension of use of pullulan (E 1204) to several food categories (EFSA-Q-2020-00517)**

The FAF Panel discussed all parts of the draft opinion. The opinion was unanimously adopted, subject to the incorporation of changes as agreed during the meeting and editorial changes. The full text of the opinion will be available in the EFSA Journal.

### **6.3 Re-evaluation of acesulfame K (E 950) (EFSA-Q-2011-00721)**

The Panel discussed the technical part, ADME and genotoxicity section and endorsed the respective sections of the draft opinion, subject to incorporation of changes as suggested during the meeting.

Based on the comments received during the current plenary meeting the draft opinion will be further elaborated and will be scheduled for possible further discussion at a forthcoming Plenary meeting.

### **6.4 Re-evaluation of neotame (E 961) (EFSA-Q-2011-00740)**

The Panel discussed the technical part and exposure section and endorsed the respective sections of the draft opinion, subject to incorporation of changes as suggested during the meeting.

### **7.1 Draft opinion on pectin rich extract from Coffea arabica (EFSA-Q-2022-00486)**



The Panel was consulted regarding the additional data received on this application dossier and taking into account the advice from the Panel, the FAF WG on Application on Food additive will proceed with the assessment.

## 8. Feedback from the Scientific Committee/ Scientific Panels/EFSA/ EC

### 8.1 Scientific Committee/Panel(s) including their Working Groups

The Panel was informed about the items discussed at the latest Scientific Committee meeting and activities related to the Scientific Committee Working Groups.

### 8.2 European Commission

The European Commission (EC) informed the Panel of some concerns raised by some EU Member States with respect to adverse effects related to high glycerol content in slush ice concentrate<sup>2,3</sup>. The Panel was made aware of an assessment by the German Federal Institute for Risk Assessment (BfR) that will be published soon on the BfR website. The EC anticipated the possibility of sending a mandate to EFSA to request scientific advice on this issue.

### 8.3 FAF Panel Working Groups

Meetings of the FAF WG on Food Additive Applications took place since the last FAF plenary meeting and an issue was brought to the attention of the Panel (see section 7.1) further to what is already recorded in the [minutes of the WG](#).

### 8.4 EFSA

The Panel was informed on the ongoing activities related to the implementation of the monitoring of food additives and food flavourings in accordance with Article 27 of Regulation (EC) No 1333/2008 and Article 20 of Regulation (EC) No 1334/2008, respectively.

The monitoring programme will start in 2025 with a pilot aimed at collecting occurrence data (analytical data, use levels, presence data) on the three food additives Green S (E 142), Tartrazine (E 102), Ponceau 4R, Cochineal Red A (E 124) and on the two flavourings caffeine (Fl-No 16.016) and pulegone (substance listed in Annex III of Regulation (EU) No 1334/2008), selected by the European Commission and the Member States. The report from the first pilot phase will be issued in 2026.
