# 11TH IUCLID PSN MEETING FEEDBACK SURVEY

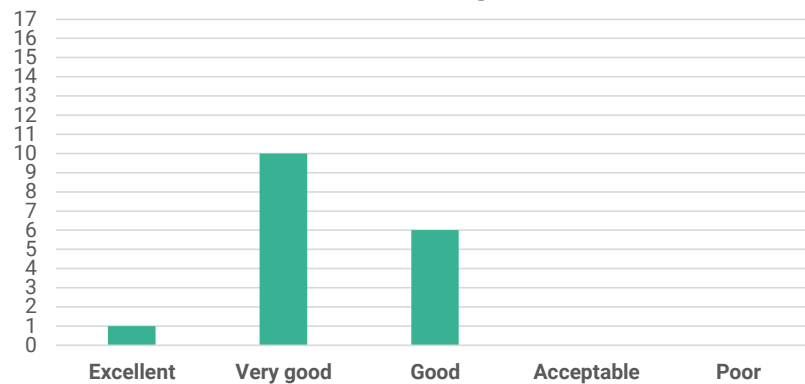
- Survey shared with **participants of the 11th meeting** (53 participants)

- Feedback was collected **anonymously**; however, name/email address could be provided on voluntary basis (1 expert from Spain disclosed identity)



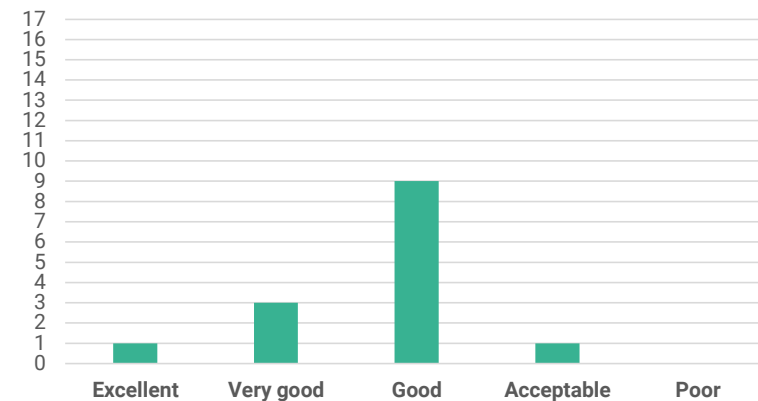

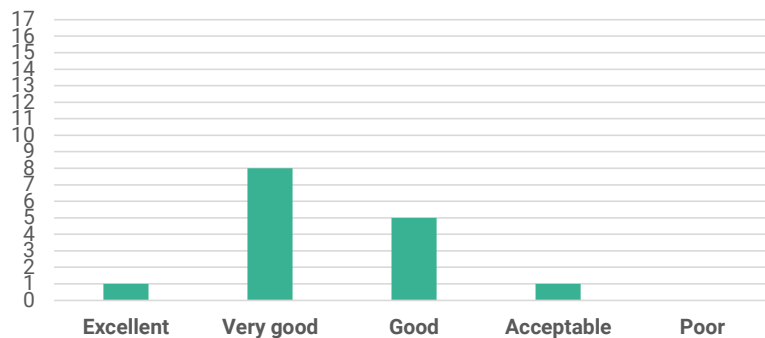
How satisfied were you with the **overall meeting?**



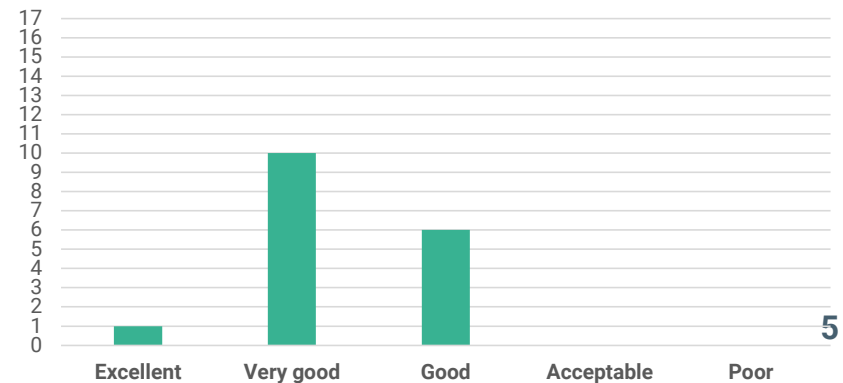
How satisfied were you in relation to **duration of the meeting?**

# REPLIES

## 1. DURATION OF THE MEETING → split MEETING in 2 half days ?

*"It is a very **packed agenda**, making all presentations very condensed"; "Appreciate the efficient meeting however always welcome extra discussion time, especially to learn from MS experiences"; "A virtual meeting should be done on **2 half days** - more then 6 hours net of presentations is too long in one go"; "**The online meeting was running over more than 6 hours** (breaks subtracted); at least for me it is difficult to focus over such a long period. If others have a similar comment, you might switch to two half day online meetings or go for **1 online meeting and two F2F meetings**"*

## 2. MEMBER STATES FORUM SPACE → re-start with MSs-only sessions ?

*"Some kind of **MS forum** would be beneficial"*

## 3. TOPICS TO BE DISCUSSED: data re-use and IUCLID trainings

*"Continue insight around ideas of **re-use of IUCLID data** and role of **AI** in chemical safety assessment"; "Data reuse topic should be continued and expanded"; "IUCLID development is moving very fast and it is hard to keep track with the changes, especially for users that only use IUCLID on partial time, but when they use it, they must use it proficiently."*

*"**A single entry point for self training is much appreciated.** At the moment there are pages with manuals of the EFSA site, on Zenodo, etc.. A new user does not know where to look for information to be sure to get the comprehensive package. Training on the use of IUCLID for MS evaluators would be welcome - NoS check, accordance check, confidentiality checks, replies to EFSA, best practices on producing a DAR/RAR based on the report generator files (BTSF?)"*

## 4. MEETING MATERIAL to be shared in advance

*"It should be really interesting to have **access to the material of the presentations in advance**, or at least at the moment of the speeches; "Sometimes slides go very fast and the possibility to check links provided from the original sharepoint files is minimal (links do not always work). But as the meeting was already quite long I do understand this*



# WHICH ASPECTS OF THE MEETING DID YOU LIKE THE MOST?

## GENERAL COMMENTS ON THE MEETING

*"Clear structure and the opportunity for open discussion"; "Very specific topics and time allocated for the discussions"; "All the themes discussed were really **interesting**"; "The discussion around the topics presented. Even though not always constructive it is good that there is enough room available and **openness** to have these discussions."; "The **constructive atmosphere - the group is now together for some years and overall functioning well. Even critical comments can and should be made**"; "Possibility to ask questions after each point"*

*"Great to see just how many EFSA folk are involved in supporting the IUCLID challenge and to find out who does what, **helpful to put faces to the names for different stakeholders too**"; "**Open discussion** on all topics and participation of most member states"; "Discussion with various input from MS, EFSA and stakeholders. It is nice to experience that **all receive the same value**"; "Multiple-participation from different sectors"; "**Participants**"*
