# 4. Agreement of the minutes of the 133<sup>rd</sup> PPR Panel Plenary meeting held on 30 September/1 October 2025, via teleconference

The minutes of the 133<sup>rd</sup> PPR Panel plenary meeting were agreed by written procedure on 17 October 2025.

### 5. Scientific output(s) submitted for discussion/adoption

5.1 Request for revision of Terrestrial Ecotoxicology Guidance (<u>EFSA-Q-2024-00463</u> and <u>EFSA-Q-2024-464</u>)

The draft protocol for the revision of the terrestrial ecotoxicology guidance was presented to the Panel, including changes implemented following the review by the Panel members Emily McVey, Antonio Finizio, and Paul Van den Brink. The protocol was endorsed by the Panel for public consultation scheduled for December 2025-January 2026.

The Panel was also updated on the progress made for the development of a Statement on indirect effects.

5.2 Application of PBK modelling for the QIVIVE of DNT IVB data for pesticide active substances (EFSA-Q-2024-00299)

The Panel was informed about the major/main comments to the draft opinion and annexes received by the reviewers (Judy Choi, Maeva Giraudo and Martin Paparella) and how they have been addressed by the Working Group.

The Panel unanimously adopted the opinion for publication.

5.1 EC mandate to develop guidance on critical appraisal of evidence as part of the systematic review methodology (EFSA-Q-2024-00584) and to update the EFSA guidance on open literature review in the context of the Regulation (EC) No 1107/2009) (EFSA-Q-2024-00585)

The Panel was informed about the status of activities for the terms of reference (ToR) 1 of the EC mandate, i.e. the development by the Scientific Committee of a guidance document on critical appraisal of evidence as part of the systematic review methodology applicable for all food and feed safety assessments, including chemicals and microorganisms used as active substances in plant protection products.
