Upon request from EFSA, representatives of Ramazzini Institute were given the opportunity to present at a technical hearing the experimental design of the study conducted in mice with sucralose, the results obtained and to elaborate about the additional information available. Following discussion during the hearing, a number of points requiring further clarification were identified. After the hearing was finished, and the hearing experts left the room, the WG briefly discussed the clarifications provided by Ramazzini Institute.

EFSA will follow up by providing the applicant with a written summary of the points discussed with the next steps and relative timelines.
