



EFSA Public Consultation – Specific Privacy Statement

Data section of the Scientific opinion on Risk assessment of African swine fever and the ability of products or materials to present a risk to transmit ASF virus:

1. Objective

The objective of EFSA's public consultations is to receive the views of stakeholders or people concerned by the specific topic of the consultation and to publish these on the EFSA website, under the responsibility of the Head of Unit in charge who is also the controller with regard to processing of personal data. As the public consultation process implies the collection and limited further processing of certain personal data, Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies¹ is applicable.

2. Which personal data are processed and how?

The personal data collected and further processed are data necessary for the participation in the public consultation, such as your first and family name, affiliation data, address information, e-mail, as well as your contribution on the topic of the public consultation. The processing of personal data linked to public consultations is necessary for the management and functioning of EFSA, as mandated by EFSA's Founding Regulation².

3. Information on the electronic tool

EFSA public consultations are carried out by means of the European Commission's official survey management tool 'EUSurvey', the reference installation of which is hosted at DG DIGIT of the European Commission. Your contributions are collected in the DG DIGIT datacentre. After the closure of the consultation, an EFSA staff member in charge downloads in a secure manner the data file with the contributions into EFSA's Document Management System with a restricted access on a need to know basis.
