The CEF Panel discussed the draft opinion but suggested minor modifications, therefore it was agreed to adopt the opinion by written procedure.

#### **6.4 Draft opinion on Copolymer wax ethylene vinyl acetate** ([EFSA-Q-2013-00282](#))

The draft opinion was discussed and revisions in the area of toxicity were proposed to the CEF WG Food Contact Materials. The opinion was not adopted and will be scheduled for possible adoption at one of the upcoming plenary meetings.

#### **6.5 Draft opinion on BPA** ([EFSA-Q-2012-00423](#))

The members of the CEF Panel were informed in depth on the comments received during the public consultation process of the draft exposure assessment and how the members of the WG BPA exposure proposed to take these comments into account. In addition, the draft parts on toxicokinetics, dose-response modelling and the endpoints relevant for the risk characterisation were discussed. The members of the CEF Panel provided further steering to the WG BPA exposure and WG toxicology.

#### **6.6 Draft opinion on FCM Guidelines** ([EFSA-Q-2011-00107](#))

The members of the CEF panel discussed all chapters related to the draft new guidance for the presentation of an application for safety assessment of a substance to be used in food contact materials prior to its authorisation and the panel endorsed the document for public consultation. The HoU of FIP outlined that EFSA will propose the date for public consultation and will inform the CEF Panel on the outcome.

## **7. New Mandates**

Overall, ten new requests falling within the remit of the CEF Panel were received by EFSA since the last plenary meeting. Two requests related to Enzymes ([EFSA-Q-2013-00789](#) and [EFSA-Q-2013-00790](#)), seven requests falling within the area of FCMs (one application related to substances [EFSA-Q-2013-00641](#); four applications related to recycling processes [EFSA-Q-2013-00754](#), [EFSA-Q-2013-00753](#), [EFSA-Q-2013-00724](#), and [EFSA-Q-2013-00613](#), three applications related to active and intelligent packaging [EFSA-Q-2013-00639](#), [EFSA-Q-2013-00725](#) and [EFSA-Q-2013-00726](#) and one request related to the re-evaluations of flavourings [EFSA-Q-2013-00816](#). For most of these applications the APDESK unit is currently carrying out the completeness check and the registration is not yet completed. The Panel received also a mandate to review the information provided by Joint Reinforced Plastics Working Group and to advise on whether the suggested approach provided in the industry guidance document is suitable to demonstrate that when glass fibre sizing in glass fibre reinforced plastics for food contact satisfies the requirements of Art. 3 of Regulation (EC) No 1935/2004 ([EFSA-Q-2013-00838](#)). The Panel expressed concerns that under the currently high workload it is not possible to deliver this opinion at the requested time (July 2014) and indicated that an extension of the deadline should be asked to the EC.

### **8.2.5 WG Genotox**

The chair of the WG reported from the last WG meeting and on challenges to identify dates for meetings as well as to have sufficient resources to make progress on the draft opinions. It was proposed that a meeting with the chairs of the WG flavourings and WG genotoxicity and EFSA staff, and EC should be organised in the near future to identify options for streamlining the workflow related to data submissions in the area of flavourings.

## **8.3 EFSA**

### **8.3.1 General matters**

The Head of the FIP Unit shortly informed the members of the CEF Panel on the following topics:

- Outcome of the 58<sup>th</sup> Management Board meeting held on 24.10.13
  - The Board appointed Bernhard Url as Acting Executive Director of EFSA and the Commission representative described the procedures and timescale for the selection and appointment of a permanent Executive Director.
  - EFSA's presented a progress report on activities covering the period since the last Board meeting in June. The Members congratulated EFSA for the delivery of a significant work programme in that period;
  - The Board discussed EFSA's strategic orientations over the coming three-year period in light of the need to finalise the Multiannual Plan 2014-2016 for the December 2013 Board meeting and in view of the establishment of a corporate EFSA Strategy in 2014. The Board welcomed EFSA's approach to streamlining strategic and planning documents;
  - The Board adopted EFSA's 2014 Work Programme for Grants and Procurement in Science and approved amendments to the Article 36 list of organisations;
  - EFSA presented an update on the renewal of EFSA's ANS and CEF Panels which included information on the breakdown of applicants by gender and nationality, communication activities, and timetable;
  - 
  - EFSA presented an update on the EU Menu project, noting the changes in funding since the project was first proposed and highlighting the effective European cooperation in taking the project this far despite the economic restrictions;
- Outcome of the 49<sup>th</sup> Advisory Form meeting held on 25 to 26. 09.13
  - The FIP network was approved, the mandate is published ([EFSA-Q-2013-00591](#)), and the nomination of candidates can now take place. FIP unit plans to hold its first Network meeting in 2014 in the area of FCMs. The CEF Panel will be involved and informed in due time related to the agenda of the first network meeting.

In accordance with EFSA's Policy on Independence and Scientific Decision-Making Processes and the Decision of the Executive Director implementing this Policy regarding Declarations of Interests, and taking into account the specific matters discussed at the meeting in question, the interests above were deemed to represent a conflict of Interest.
