# 6.16 DSM Nutritional Products-Draft Opinion on the extension of uses for DHA and EPA-rich algal oil from Schizochytrium sp. as a Novel Food ingredient (EFSA-Q-2014-00218)

#### Others

#### 6.17 Draft opinion on Safety assessment of caffeine (EFSA-Q-2013-00220)

On 18 September, the draft opinion was presented and different sections related to the safety assessment of caffeine were discussed. The main changes introduced into the opinion since the last Plenary meeting were outlined and discussed. The current revised structure of the opinion was agreed.

The Panel was informed that new data on food consumption in a number of Member States had recently become available to EFSA. The NDA Panel considered it highly important to include these data in the intake assessment for caffeine, and therefore postponed the opinion's endorsement for public consultation. A revised draft which will take into account the new food composition data will be scheduled for discussion and possible endorsement for public consultation at the Plenary meeting in December 2014.

#### 7. New Mandates

#### 7.1 Applications pursuant to Article 14/13.5 of Regulation (EC) no 1924/2006

The Nutrition Unit informed the Panel about the status of claims applications since the last Plenary meeting.

Article 13.5 claims (claims based on newly developed science and/or which include a request for the protection of proprietary data) – 8 new applications were received: "Glucose contributes to the maintenance of normal brain function"; "Glucose contributes to normal cognitive function"; "Glycaemic carbohydrates contribute to the maintenance of normal brain function"; "Dextrose Tablets contribute to the maintenance of normal brain function"; "Combination of standardized pomegranate pomace extract and greater galangal rhizome powder increases the number of motile spermatozoa in semen"; "SYNBIO® persists in the intestinal tract and favours the natural regularity contributing to maintain and improve human intestinal well-being";



"Clarinol® or Tonalin® contributes to a reduction in body fat mass"; "Coffee C21 contributes to the maintenance of DNA integrity in cells of the body".

 Article 14 claims – 2 applications were received: "L-tug lycopene has been shown to lower/reduce blood cholesterol. High cholesterol is a risk factor in the development of coronary heart disease"; and "Salt is essential for the electrolyte balance of the body". Two applications were withdrawn: "Complex Carbohydrates and supply of metabolic energy"; and "Milk protein, and, growth and muscle development".

Rapporteurs have been appointed for the new applications received. EFSA NDA guidance documents on health claims will be taken into consideration for the evaluation of the new applications received.

## 8. Feedback from the Scientific Committee/the Scientific Panel, Working Groups, EFSA, the European Commission

#### 8.1 Scientific Committee and other Scientific Panels

At the last Scientific Committee (SC) meeting held on 8-9 July 2014, the vice chair of the NDA Panel presented to the SC an update on activities in the areas of nutrition.

The adopted NDA Opinion on health benefits of seafood (fish and shellfish) consumption in relation to health risks associated with exposure to methylmercury (EFSA-Q-2013-00167)<sup>7</sup> was also presented to the SC. This opinion complements the CONTAM opinion on the risk for public health related to the presence of mercury and methylmercury in food that was adopted in 2012. The Scientific Committee discussed the original mandate received from the European Commission and underlined the difficulty of doing a formal risk-benefit assessment; indeed, the various type of data available would make a quantitative risk-benefit assessment very difficult. The Scientific Committee agreed to prepare a statement reviewing the outcome of the previous work done by the CONTAM and NDA Panels by the end of 2014.

During the meeting the SC endorsed the **Draft opinion on revised structure of EFSA's opinions and statements** (EFSA-Q-2012-00786). The document will be published and then implemented by all the EFSA Panels for a period of about 10 months. After this testing phase, feedback from the Panels will be gathered and the new structure will be revised, if needed.

#### 8.2 Working groups

Postponed to a future Plenary meeting.

#### 8.3 EFSA

Per Bergman informed the Panel about the scope and status of the Matrix Project, which is an EFSA Organisational Development project aiming to develop an IT-based system for the electronic management of the applications received by EFSA for risk assessment in the area of regulated products. The Panels dealing with regulated

products were invited to review and confirm the completeness and correctness of data requirements, which have been retrieved and based on the Scientific Guidance Documents developed by EFSA and its Scientific Panels.

With respect to the evaluation process of application dossiers submitted to EFSA, the Panel was informed about initiatives undertaken by the REPRO department to increase Efficiency. The list of measures/actions for consideration include: how outsourcing can lead to increased efficiency and lower workload; greater use of hearing experts (if their written reply to stop-the-clock questions are unclear); update Guidance Documents for applicants on a regular basis or publish Explanatory Notes on Guidance documents (Technical Reports of EFSA); EFSA staff members to take greater part in drafting outputs; meetings with chair of panel/WG prior to meetings to resolve contentious issues, and to clarify procedural issues before meetings, etc. Panel members were invited to provide their feedback.

Per Bergman will leave EFSA to take up a new position as Head of the Risk and Benefit Assessment Unit at the Swedish National Food Agency on 01 December 2014. Juliane Kleiner will serve as *ad interim* Head of REPRO and Tobin Robinson will be *ad interim* Head of SCISTRAT.
