## **1. Welcome and apologies for absence**

The Chair welcomed the participants.

Apologies were received from Bertel Strandbygaard (Denmark), Nicolas Rose (France), Spyridon Kritas (Greece) Ádám Bálint (Hungary), Beatrice Boniotti (Italy) and Francesco Berlingieri (European Commission, DG SANTE).

## **2. Adoption of agenda**

The agenda was adopted without changes.

## **3. Declarations of Interest**

An Oral DOI was requested at the beginning of the meeting. No conflicts of interests were identified.

**4. Agreement of the minutes of the 1st meeting of the Network on Porcine Epidemic Diarrhoea (PED) for the project: 'Request for scientific and technical assistance on the collection and review of updated scientific epidemiological data on porcine epidemic diarrhoea (PED)' held on 20 March 2015, by web-conference.** The minutes were agreed.

## **5. Topics for discussion**

### **5.1 Draft reporting guidelines (discussion and approval)**

It will be specified that clinical signs can be very variable and the ones described in the reporting guidelines are examples. Breed will be removed. The ability to list combinations of material/test will be added. Case definition will be expanded to include newly added sample materials and tests. In the reporting of the data in the EFSA Scientific Reports the presentation of region and size of a herd will not be linked for specific herds, in order to avoid the possible identification of specific herds. Appropriate fields will be added to indicate whether the testing referred to individual animal samples or pooled samples, and in the latter case, what was the number of individual animal samples included in each pool. Variable 'PriorY' will be removed and instead the information from the previously published Scientific Opinion of the EFSA Panel on Animal Health and Welfare will be used. In the list of possible control measures an option to report measures related to transportation (e.g. cleaning/disinfection of transportation trucks etc.) will be added.

### **5.2 Reporting serologic surveys**

Experience with serological testing is variable among MS. Caution is required for the interpretation of serological test results, especially when the disease history in the farm is unknown. Participants will read again the part of the draft reporting guidelines on 'Reporting of serological surveys and other testing' and will send any comments they may have on it, by the beginning of next week.

### **5.3 Practicalities of data reporting**

Some MS need a mandate from their competent authorities in order to be able to collect and report all the required data. EFSA staff will present the study and the reporting guidelines at a PAFF meeting in April, during which they will request from the MS CVOs to endorse the sharing of these data. Under-reporting and reporting bias are concerns for this data collection. The data collection scheme will be re-evaluated after the first data collection is complete and, if necessary, adjustments will be proposed for the second data collection.
