

# **Unit costs substitute real costs**







SUBSISTENCE €/day



- Find their origin in the simplification of Financial Regulation – Article 182 of Commission Delegated Regulation (EU) No 2015/2462 of 30 October 2015
- Are based on historical data (EFSA's data compared to Commission) and reflect the annual labour costs per country (a statistic published by Eurostat)

# Simplifications



- Easier budget estimation
- Easier costs declaration at the project end
- Less documents required (e.g. no payslips)
- Higher transparency regarding the expectable grant
- Quicker grant payment




## 2. Staff cost = number of days x daily rate

#### 3. Possible controls:

- Possible ex-posts audit













# **Travel : How does it work**

- Per transport type and distance
- > Covers the transport to reach the meeting place: car, train, flight

Type of transport	Distance in Km	Travel Unit cost
Car, Train	Any distance	0.22 €/Km
Flight	300 - 599.99	400€
Flight	600 - 1.199.99	450€
Flight	> 1.200	500€

Inter-continental flights not included: case by case estimation + declared real incurred costs





## **UNIT COSTS IN GRANTS**

# Subsistence: How does it work



- accommodation, meals, local transport (car, parking, taxi, public transport), and sundry expenses (fax, internet ...)
- > for missions > 50 km
- no overnight stay / or hotel paid by others: allowance 70% reduction
- 10% allowance reduction for each meal offered
- Allowance calculation length of the mission

DURATION	NR OF PER DIEM SUBSISTENCE
= 24 hours</td <td>1 full daily allowance</td>	1 full daily allowance
> 24 hours = 36 hours</td <td>1.5 x daily allowance</td>	1.5 x daily allowance
> 36 hours = 48 hours</td <td>2 x daily allowance, etc.</td>	2 x daily allowance, etc.
