# **Background**

- Bee Symposium/EFSA's Strategy 2020/ MUST-B project,
- EFSA pledged to facilitate the next steps by organising a discussion group to agree the terms of reference for the partnership.
- importance of greater harmonised data collection and sharing and the need for enhanced dialogue with stakeholders, Member States and institutional partners in the context of to the EU risk assessment.
- Direct benefits for stakeholders; creation of synergies, facilitation of data sharing and access, and ultimately increased evidence and best practice on bee health.



# **Background**

- EFSA's Stakeholder Engagement Approach (SEA)
- Discussion Groups "learning systems" that allow EFSA to capitalise on stakeholders' specialist knowledge in specific areas
- provide stakeholders with information about different aspects of the Authority's work
- EFSA and stakeholders positive experience with discussion groups on topics such as emerging risks, data collection, allergenicity of GMOs, endocrine disruptors






### Selection and composition

- Call for expression of interest launched on 20 September deadline for submission of applications was 9 October 2017.
- In total, 23 organisations submitted nominations
- Selection criteria:
- Interest in the field and expected benefits;
- Role and remit of the organisation at EU level;
- Achieving a balanced representation of stakeholder interests;
- expertise of expert to cover a wide range of technical and scientific areas, including bee health (i.e. beekeeping, veterinary sciences including bee diseases, ecotoxicology, chemical contamination, honey production), climatology and social sciences.
