1. Welcome and apologies for absence

The Chair welcomed the participants.

Apologies were received from Flemming Bager (Denmark), DG SANTE D1 and Stefano Cappe (EFSA).

2. Adoption of agenda

The agenda was adopted without changes.

3. Discussion of the Objectives and Terms of Reference for the Task Force

The Chair presented the background to the Advisory Forum's decision to institute a Task Force to examine the need for common thinking amongst EU Member



States and other stakeholders including EU institutional stakeholders (e.g. EFSA, ECDC, ECHA, DG SANTE) in their approach to the collection and analysis of data relating to food safety and EFSA's remit.

There may be some difficulties relating to having a clear strategic understanding of data at a high level in food safety organisations and in relation to Member States' responsibilities and EFSA responsibilities.

The Chair presented the terms of reference for the task force. Within this context, he explained that the role of the task force is to give advice to the EFSA Advisory Forum on where problems are and how EFSA could solve them

3.1 Data Collection and Reporting

This is the starting point and the perspective of origin for task force members. There is a paradigm shift in data management, including at EFSA, from collection/transmission to stakeholder partners towards opening access for partners. In the EFSA case, this could mean providing EFSA with access to national systems to retrieve what data they require for a particular remit. Data security, the General Data Protection Regulation (GDPR) and confidentiality issues would need to be considered as well as exploration of mechanisms for reducing the reporting burden considering the needs of EFSA, DG SANTE and international bodies.

3.2 Data Modelling

This aspect includes structuring data to reflect reality. The need for the national data model to differ from the EFSA data model should be considered as well as how to manage those differences and whether sharing of national variations amongst Member States may be of value.

As many users of data models designed for risk assessment purposes are risk managers, how the models serve both risk assessment and risk management purposes merits consideration e.g. extensions of SSD2 (standard sample description, version 2) in a national context; – should we aim to harmonise these differences or simply recognise their differences? As well as considering the value of a harmonisation process, the costs should be evaluated.

3.3 IT Architecture

Task force members discussed the need to understand the different architectural approaches used to manage food safety data and whether a group for exchange of expertise and best practice would be beneficial.

3.4 Data Analysis

Task force members considered the extent to which national food safety organisations include data focussed objectives in their strategic plans and regard their data as assets in the assessment, management and communication of risk. This could include the formation of a cross domain data management/architecture expert group to consider whether data is used, and should it be used, to influence the implementation of official controls - not determining official control plans but informing decisions made in the management of official controls.



A proposal of the time lines for the task force was presented considering the timing of Advisory Forum meetings.

4. Tour de Table

The participating Member State representatives expressed support for the objectives and Terms of Reference of this task force and briefly described their national data collection systems. It was proposed to invite other food safety data users to relevant meetings.
