- 1. developments in analytical methods for micro- and nanoplastics
- 2. developments in exposure assessment of humans to micro- and nanoplastics
- 3. developments in hazard identification and characterisation for micro- and nanoplastics
- 4. developments in understanding consumer perceptions of micro- and nanoplastics in food

At the review stage, the Scientific Programme Committee may allocate accepted works to a different theme, if considered to be more appropriate for the submitted abstract.

Presentation types

Submitted abstracts will be considered for the following presentation formats:

- Poster exhibit

Traditional paper poster A0 size (1189mm x 841mm, portray)

Poster pitches, in addition to poster exhibit

Oral 3in3 presentations (3 slides in 3 minutes)

- Oral presentation in the main scientific programme

Approx. 15 minutes, with slides

(not applicable for theme 4 on consumer perceptions)

Please submit your abstract in English before **14th February 2020** (midnight CET). Each applicant can submit only one abstract. Abstracts can only be accepted via on-line submission. Sorry, but we won't accept incomplete or late submissions.

- Co-author(s): last and first name, organisation NB: the person submitting the abstract is considered the main author
- Abstract: introduction (word limit: 250)

- Abstract: results (word limit: 250)
- Abstract: discussion (word limit: 250)
- Up to 2 tables or figures
- Up to 5 references
