### 5. Scientific outputs submitted for discussion and/or possible adoption, updates on ongoing activities, new projects

## 5.1. Request of an opinion on the genotoxic potential of triazine amine (metabolite common to several sulfonylurea active substances) (EFSA-Q-2018-00830).

The Panel was informed on the last update of the draft scientific opinion made by the Standing Working Group on genotoxicity during the WG meeting in October. Moreover, the draft opinion including comments from the peer reviewers was presented for discussion and the final conclusions were agreed by the Panel. It was also agreed the need to request the working group on genotoxicity to provide further explanations in the text in order to increase transparency and postpone the adoption of the opinion, including by written procedure depending on the needs.

## 5.2. Development of Adverse Outcome Pathways relevant for the identification of substances having endocrine disruptors properties (EFSA-Q-2019-00492).

The chair of the Working Group informed the Panel about the PPR Panel Working Group implementation and outcomes from the  $1^{st}$  WG meeting held in November (via web conference). The project plan and the actions following the  $1^{st}$  meeting were also presented.

# 5.3. Scientific Opinion of the PPR Panel for developing Integrated Approaches to Testing and assessment (IATA) case studies on developmental neurotoxicity (DNT) risk assessment (EFSA-Q-2019-00100)

The Panel was updated on the status of the Scientific Opinion for developing IATA case studies on DNT risk assessment. The systematic scientific assessment of the evidence for the substances selected for the case studies was presented, elucidating the methodology used for evidence appraisal by the PPR Panel Working Group with the support of the AMU Unit. It was also clarified that the draft opinion will be circulated for commenting before the endorsement of the document for the public consultation, foreseen during the 2<sup>nd</sup> Q 2020.

## 5.4 Framework for conducting environmental exposure and risk assessment for transition metals when used as active substances in PPPs (EFSA-Q-2019-00374)
