## AFC

- 27 opinions adopted on:
  - Food additives: lycopene, rosmarinic acid, Southampton study
  - Nutrient sources: vanadium sources
  - Flavouring: 2 flavouring groups, 3 revised Flavouring Group Evaluation, 12 groups of substances evaluated by JEFCA
  - Food contact materials: 6 substances
- Split of the AFC panel (update)

## AHAW

- 1 opinion adopted on tuberculosis testing in deer
- New mandate on list and criteria for susceptible fish species
- Fish welfare WG meeting with more than 45 MSs experts

## BIOHAZ

- 4 opinions adopted on:
  - microbiological risk assessment on Salmonella in meat
  - safety of hydrolysis on dead pigs and dead rabbits
  - effect of 4 antimicrobial substances on antimicrobial resistance
- 1 report published on TSE in ovine and caprine animals (opinion of 8/03/07)
- Panel agreed to launch public consultation of draft opinion on “food borne antimicrobial resistance as a biological hazard”
- 1<sup>st</sup> meeting on Art. 36 consortium on quantitative microbial risk assessment on Salmonella in pig.

## CONTAM

- 5 opinions adopted on:
  - perfluorooctanil sulfonate, perfluorooctanoic acid and their salts
  - mercury in animal feed
  - cross-contamination of non-target feed by decoquinate, robenidine, halofuginone hydrobromide
- 1 statement on safety of fatty acid esters
- Preparation of the Scientific Colloquium on acrylamide 22-23 May (in collaboration with SCA and Comms)

## FEEDAP

- 1 opinion adopted on safety and efficacy of Phytase as a feed additive
- Meetings with DG SANCO, CRLs and the industry (FEFANA) to discuss and set priorities for the forthcoming re-evaluation of 2500 feed additives (by 2010)

## GMO

- 3 opinions adopted on:
  - GM aspects of microorganisms for the production of L-valine (with Feedap)
  - GMT 45 oilseed rape for placing on the market and for existing products
- 2 reports published :
  - Special AF on GMO risk assessment
  - Self-task on animal feeding trials

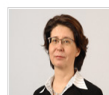

Dr. Riitta Majjala is Director of Risk Assessment at EFSA since 2008. Her directorate supports EFSA's core business of delivering risk assessments and Scientific Opinions to risk managers by providing the secretariat for each of EFSA's Scientific Panels.

Before joining EFSA her career was based in the Finnish public administration, where her most recent appointment was as Head of the Animal Health and Welfare Unit of the Finnish Food Safety Authority (EVIRA). She was a professor and head of the Risk Assessment Department at the National Veterinary and Food Research Institute from 2001 to 2005 and Development Director (risk analysis) from 1998-2001. She has also worked as an adjunct professor for the University of Helsinki's Department of Food and Environmental Hygiene. She has held a number of international roles including member of the European Commission's Scientific Committee on Veterinary Measures Related to Public Health, Vice Chair of EFSA's BIOHAZ Panel and President of the European College of Veterinary Public Health.

She holds a Doctorate of Veterinary Medicine (DVM) and a PhD from the College of Veterinary Medicine in Helsinki as well as a postgraduate degree on food hygiene and a specialist degree in Veterinary Medicine on Infectious Animal Diseases. She also holds a diploma from the European College of Veterinary Public Health (Dipl. ECVPH) and is a lecturer on food hygiene in the Helsinki University.

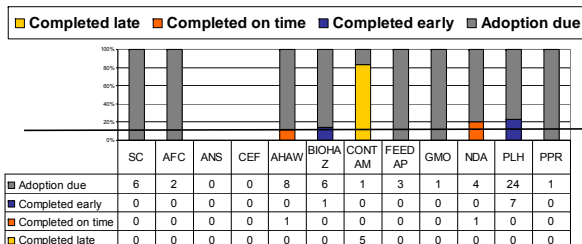

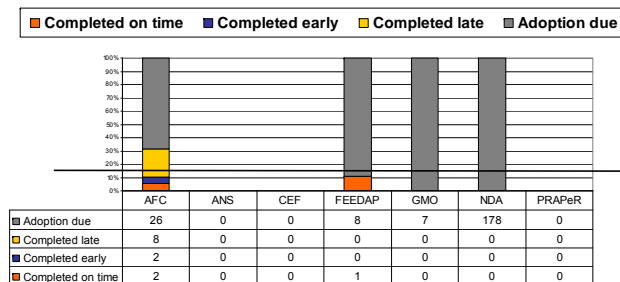

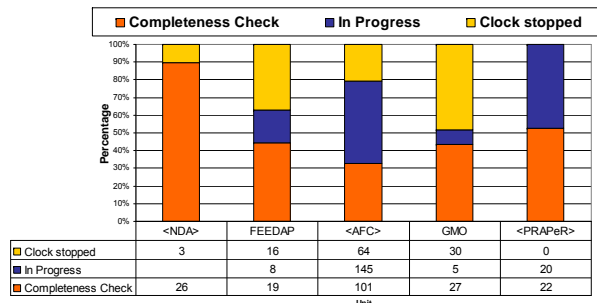
Generic opinions analysis by adoption date and deadline date, February 2008



Application opinions analysis by adoption date and deadline date, February 2008

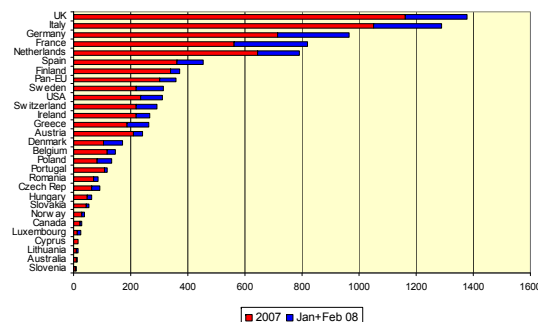


Active applications by status and unit, Feb 2008

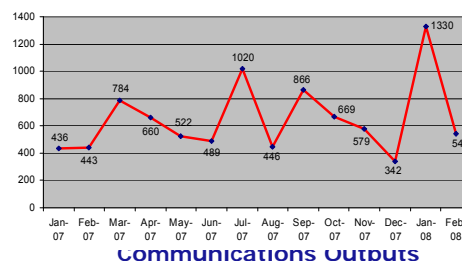
