RECOMMENDATION TO THE MANAGEMENT BOARD ON THE NEW LISTS OF MEMBERS AND ASSOCIATED MEMBERS OF THE STAKEHOLDERS CONSULTATIVE PLATFORM

I. Background

On the 18th June 2009, EFSA's Management Board decided to renew the EFSA's Stakeholder Consultative Platform and adopted revised Terms of References. The Management Board decided to renew the Stakeholders Platform by launching a public Call for expressions of interest for the renewal of the Platform membership and associated membership.

The Call for expressions of interest and the related Terms of Reference were published on EFSA's website on the 26th June 2009. The deadline foreseen to submit the applications was the 31st August 2009 (two full months).

II. Applications received

EFSA received 53 applications overall.

The current Platform counts **24 full Members and all of them expressed their interest to be confirmed** for full membership.

EFSA received **16 applications coming from new organizations**, not on the list of members or associated members, who applied to become full member or associated member.

EFSA received 13 applications from the 34 existing Associated Members requesting to become full member or alternatively to confirm their associated status.

The remaining 21 existing Associated Members (out of 34) did not apply.

III. The compliance with the criteria and the comparative assessment

Details related to the procedure and the assessment of the applications received are described in **Annex I**. The table annexed as **Annex II** represents, per categories and per areas of competence, all organizations, achieving the essential requirements, which applied for membership and associated membership.

ANNEX I: SUMMARY OF THE ASSESSMENT OF THE APPLICATIONS FOR THE RENEWAL OF THE STAKEHOLDERS PLATFORM MEMBERSHIP AND ASSOCIATED MEMBERSHIP

Evaluation committee

The Call for expression of interests was launched on the 26th June. The deadline for receiving the applications was the 31st August 2009.

An evaluation committee was appointed by the Executive Director and met on the 4th and on the 8th September to assess all applications received. Members of the evaluation Committee were:

Olivier Ramsayer (Director of Administration), Christine Majewski (Strategic Advisor), Karen Talbot (Communications Advisor), Carola Sondermann (Senior Scientific Officer), Lucilla Gregoretti (Scientific Officer). Luisa Venier (Legal Officer) provided the Secretariat.

EFSA received 53 applications overall.

II. The compliance with the criteria and the comparative assessment

The Evaluation committee assessed the applications against the criteria published in the Terms of Reference and the Call for expressions of interest¹.

Among candidates a comparative assessment was done, in order to ascertain the compliance of each organization with the criteria published and the suitability of the organizations to become full members of the Platform.

It was explicitly foreseen that those organizations that in the comparative assessment were not considered suitable for full membership, were to be considered for associated membership.

^{1.} being a EU-wide organization operating in the food chain;

^{2.} being an organization representing consumers, food operators active in the whole food chain – e.g. farmers and other primary producers-, the food industry, the food trade and NGOs active within the mandate of EFSA;

^{3.} being permanently established and well known at the EU level;

^{4.} having a legitimate interest in the remit of EFSA (for associated membership the legitimate interest can also be related only to a specific sector of EFSA);

^{5.} being representative in the field of its competence and involved in the areas within the remit of EFSA (for associated membership the area within the remit of EFSA the organization is involved in, can be sectoral and very specific);

^{6.} not having any legal obligation with EFSA.

III. General considerations of the assessment

By screening the applications the Evaluation committee framed the following general considerations:

- All the new applications were submitted from the industry sector;
- There were no new applications from organizations representing Consumers: the three
 organizations representing the Consumers put forward for membership were already members of
 the existing Platform and confirmed their intention to be full members. They are BEUC, EUFIC
 (European Food Information Council) and EuroCoop (European Community of Consumer
 Cooperatives);
- There were no new applications from organizations representing Farmers
- There were no new applications from organizations representing NGOs: All NGOs already on the list of full members confirmed their intention of being full members. They are EEB (European Environmental Bureau), Greenpeace, Friends of the Earth, EPHA (European Public Alliance), Eurogroup for Animal Welfare).

IV. General principles considered by the Evaluation committee in the assessment

The comparative assessment took in due consideration:

- The nature of the organizations, being considered as essential to **grant a balance among the different categories** represented by the Stakeholders organizations: consumers, industry (including food and feed manufacturers and processors), NGOs, farmers, traders, food operators.
- The EU-wide representativeness of the organization in the fields of competence covered by EFSA's remit:
- The extent to which the legitimate interest in the areas of EFSA is fully, directly addressed by the organization in comparison with other organizations applying to be member;
- The number of areas within the remit of EFSA in which the organization is involved and / or the extent to which these areas are covered.
- The fact that higher consideration should have been attributed to organizations representing key sectors of the food chain that were not particularly or sufficiently represented so far by the existing Members;
- The fact that higher consideration should have been attributed to organizations structured in a
 federative way, i.e. more representative of the interests of national associations of category and not
 only of single companies;
- The fact that higher consideration should have been attributed to organizations representing as their associates companies not already represented by organizations already on the list of Members or Associated Members

IV. Outcome of the comparative assessment: the list of members and associated members proposed for consideration

THE MANAGEMENT BOARD OF THE EUROPEAN FOOD SAFETY AUTHORITY,

Having regard to Regulation (EC) No 178/2002 of the European Parliament and of the Council of 28 January 2002 laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety as last amended, and in particular to article 42 thereof,

Whereas.

EFSA's Management Board agreed in June 2009 to renew the Stakeholders Consultative Platform and adopted revised Terms of references.

EFSA's Management Board decided to renew the Stakeholders Platform by launching a public Call for expressions of interest for the renewal of the Platform membership and associated membership.

HAS DECIDED AS FOLLOWS
