Cooperation activities with Member States' organisations via grants (under Article 36) and via public procurement procedures/agreements.


The planning followed a similar procedure as in previous years:

- Reviewed by the Advisory Forum and Scientific Committee
- Reviewed by the EFSA Management Team
- To be adopted by the EFSA Management Board

The WP 2011 has been drafted based on experience and lessons learnt.








Overall increase of budget allocation, nearly threefold

### Annual WPs 2007-2010 budget per priority area per year






Most of the funds continue to be allocated to supporting directly risk assessment activities (i.e. for the examination of authorisation dossiers and general risk assessment)

Grants have been mainly used to support risk assessment activities and data collection

Procurement/agreements have been mainly used for supporting the work on authorisation dossiers and data collection



Budget (proposed) for scientific cooperation with Member State organisations via <u>art.36 grants</u> (in thousand €)

Activity	Amount (€)
1. Support for the examination of authorisation dossiers	355 000
2. Preparatory work for risk assessment	630 000
3. Data collection and analysis supporting risk assessment and risk monitoring	1 270 000
Total	2 255 000
