- 565 scientific outputs finalised
- Budget execution 99%
- > Panel renewal calls (ANS & CEF, reserve lists)
- Communications strategy 2010-2012
- Institutional relations, dialogue with risk managers



Key achievements 2010



- e³ programme begins
- review of DOI implementation started
- EFSA Seat on track



Construction of European school building begins







- > 95% of outputs adopted on time
- > 99% ADol approved prior to meeting
- Generic opinions: bisphenol A, marine biotoxins, carcass contamination, Ambrosia in feeds, melamine, food irradiation, pest risk assessments, animal cloning, TSEs etc.
- Applications: feed additives, food additives, flavourings, GMOs, 2nd and 3rd batches of opinions on Article 13.1 claims, decontamination techniques etc.
- Rapid advice: chlormequat in grapes, volcanic ash-fall



- Cross-cutting issues: endocrine disrupters, benchmark dose
- Guidance document on human health risk-benefit assessment of foods
- Update on scientific developments related to cloning
- Draft guidance document on the safety assessment of applications of nanoscience and nanotechnologies

Not delivered / difficulties in 2010



- Scientific outputs & supporting publications: 565 delivered vs.
 736 planned (mid-year review June 2010)
 - Non-receipts, re-prioritisation, stop the clock mechanism, different grouping of applications, reclassification of outputs
 - delays in resubmission programme for pesticides peer review
- Work on botanicals (claims): temporarily suspended
- Science Strategy: postponed to 2011
- Risk communications guidelines: ongoing
- Full execution of grant programme although late in the year
- Challenges on EFSA's independence
