
Highlights

- Call for the renewal of ANS and CEF Panels: MB members participated in a promotional event in Bucharest
- EFSA's Management Board Chair attended the meetings of:
 - Chairs of MBs of the EU Agencies: implementation of the Commission's Roadmap on the Common Approach for EU Agencies (14 May);
 - Advisory Forum (6-7 March), Stakeholders Consultative Platform (25-26 March) and Scientific Committee (11-12 April)

Panel on animal health and welfare (AHAW)

- Opinions on Rift Valley Fever, Electrical stunning of lambs, carbon dioxide for stunning of rabbits
- Chapters on meat inspection (bovines, solipeds, farmed game and small ruminants)



Panel on plant health (PLH)

- Opinions on risks posed by *Bemisia tabaci* and risks associated with *Pinus pinea*

Panel on contaminants in the food chain (CONTAM)

- Guidance on methodological principles when establishing Reference Points for Action for non-allowed pharmacologically active substances

Biological Monitoring (BIOMO)

- EFSA-ECDC networks meeting: investigation on food-borne outbreaks and harmonised reporting of antimicrobial resistance



Panel on additives and products or substances used in animal feed (FEEDAP)

- Adopted 23 opinions on the authorisation of feed additives: technological (5), sensory (2), nutritional (6), zootechnical (10)



Food ingredients and packaging (FIP)

- CEF: 13 opinions on food contact materials (7), flavourings
- ANS: food additives (3), Allura red and polyvinylpyrrolidone-vinyl acetate copolymer
- Aspartame: Technical report on public consultation. New deadline: November 2013

Panel on protection products and their residues (PPR) and Pesticides (PRAS)

- 15 reasoned opinions on routine MRL applications; 21 reasoned opinions reviewing the existing MRLs
- 20 conclusions on pesticide peer-review of active substances, among which fipronil posing risks on bee colonies

Panel on dietetic products, nutrition and allergies (NDA)

- Health claims: 5 opinions related to Art 13.5 and two under Art. 14
- Two opinions on novel food



Panel on genetically modified organisms (GMO)

- Guidance document on environmental risk assessment for GM animals
