

5.1 Draft opinion on selenite triglycerides as novel food and source of selenium. *Applicant: BioSEL Sp. z o.o. (EFSA-Q-2015-00343)*

7. Feedback from the Scientific Committee/Scientific Panels, EFSA, the European Commission

The Panel was informed about the ongoing activity carried out by the **Scientific Committee (SC)** **Working Group to integrate and harmonise the approach regarding the setting of Health Based Guidance Values (HBGV)**, such as ADI and UL, for regulated products that are also nutrients. Some nutrients are also used in products subject to regulatory assessment, e.g. phosphates as additives, copper in pesticides and feed additives. An outline of the Terms of Reference, the key concepts and the proposed approach was presented and discussed. A consultation will take place with Panel/Unit. A draft Statement will be presented to the SC for possible endorsement for release for public consultation at its Plenary in June.

The Panel was given an overview of the **draft framework for protocol development for EFSA's non-application scientific assessments**, which was endorsed by the SC. The document defined a series of principles for the scientific assessment process (impartiality, methodological rigour, transparency and engagement) and developed a 4-step approach (plan/do/verify/report) to facilitate their fulfilment. The methods for the scientific assessment must be planned upfront in a protocol to prevent data-driven decisions and to increase rigour and transparency of the process. A pilot (implementation) phase will start for EFSA's non-application assessments, allowing the various Panels to test the framework and report back on the experience for possible further improvement of the document.

8. Other scientific topics for information and/or discussion

8.1. Draft opinion on the overall dietary exposure and safety assessment of heat-treated chia seeds (*Salvia hispanica L.*) as a novel food (EFSA-Q-2019-00254)

The Panel was informed about the status of the draft opinion, and in particular, about the information on process contaminants in heat-treated chia seeds retrieved from the literature and received from a public call for data. The draft opinion will be presented at the next WG NF meeting for further discussion and will be submitted to the Panel³ for possible endorsement for release for public consultation.

9. Any Other Business

The Panel discussed and shared lessons learned from the peer reviewing/reviewing process introduced prior to plenary meetings to improve the quality of outputs and facilitate the Panel discussions/adoption.
