



### What is phytopharmacovigilance?

# Act of 13 October 2014 on the future of agriculture, food and forests Monitoring of the adverse effects of PPP on:

- Humans, livestock including honeybees, crops, biodiversity, wildlife, water, soil and air quality, food, resistance.
- ⇒ In order to detect as early as possible any signals which may require measures to be taken to prevent or limit the risks associated with PPP

#### Three data sources

- Systematic and periodic data collection produced by the surveillance and vigilance French bodies, gathered in a unified data network
- Reporting obligation to Anses or one of his partner of potentially harmful or adverse effects
  - Article 56 of Regulation 1107/2009 extended to manufacturers, importers, marketers or professional users of PPP, advisers and trainers of those users, in addition to marketing authorisation holders
  - Doctors and veterinarians can also declare adverse effects
    - ⇒ Forms to report effects available on the Anses website
- In order to complete knowledge: *ad hoc* studies on the adverse effects of PPP (specific tax levied on marketing authorisation holders)
  - Improve knowledge of exposure, risks and impacts
  - Investigate reports of potentially harmful or unacceptable effects
  - Strengthen the global network: improve the quality and accessibility of data from the partner networks

#### Examples of harmful or unacceptable effects notified

- Phytotoxicity of a fungicide in vineyard reported by a MA holder
  - Withdrawal of the marketing authorization
- Suspicion of clustered paediatric cancers in a wine-producing area reported by the national public health agency (Santé publique France), partner of Anses for phytpharmacovigilance
  - Study in course at the national level on the basis of all the cases of paediatric cancers in France: relationships with PPP exposure?
  - Study on exposure of residents of agricultural areas to pesticides
- Maximum residue limits being exceeded for apples by a herbicide used for cereal crop growing reported by a MA holder
  - Change of agricultural practice?
