National Open Data portal in Cyprus data.gov.cy



- Competent Authority: Public Administration and Personnel Department

 Ministry of Finance
- Legal Framework:
 - 1. European Directive 2013/37/EU (amending 2003/98/EC on the use of public sector information)
 - 2. National Legislation "N.205(I)/2015"
- Scope: Making public sector data accessible, in order to be further exploitated by the private sector or other national and international organisations
- Content: More than 1000 datasets from 65 Public Organisations
- Open licence: Open Data available on the basis of the "Creative Commons" licence
- **Exclusions:** Certain data are excluded from publishing due to reasons, such as: IPR, protection of National Security, data from research projects owned by educational/research institutes, etc.
- Confidentiality: Open Data published in the Cyprus portal do not contain personal data




National Open Data portal in Cyprus data.gov.cy (cont.)



- Cyprus ranked in the top five EU countries in Open Data
- Cyprus Open Data portal ranked in the 1st place among 31 portals in Europe!

SGL Datasets published in Cyprus Open Data portal



The State General Laboratory maintains 8 datasets on the Cyprus Open Data Portal. The format of the data is CSV.

- Results of the quality control of drinking water: Six datasets are maintained which comprise the following elements: District, Water Supply Zone Code and Description, Town or Village, Sampling date, Parameter, Result, Legal limit, Unit of measurement, SGL Sample ID. The datasets of the results above the legal limits also contain information about the Compliance and Actions taken. These data are updated every six months.
 - 1. Complete dataset containing all the results of the quality control of drinking water for Microbiological parameters.
 - 2. Complete dataset containing all the results of the quality control of drinking water for Chemical parameters.
 - 3. Complete dataset containing all the results of the quality control of drinking water for Organic pollutants.
 - 4. Dataset containing the results of the quality control of drinking water for Microbiological parameters which are above the legal limits.
 - 5. Dataset containing the results of the quality control of drinking water for Chemical parameters which are above the legal limits.
 - 6. Dataset containing the results of the quality control of drinking water for Organic pollutants which are above the legal limits.



SGL Datasets published in Cyprus Open Data portal (cont.)



- Research programs: This is a list of all the research programs in which the SGL participates. It comprises the following elements: Program title, Source of funding, Duration. This list is updated annually.
- Annual reports: This is a list of all the annual reports of the SGL. It comprises the following elements: Year, Title, URL. This list is updated annually.
