### 1. WELCOME AND APOLOGIES FOR ABSENCE

The Chair opened the meeting and welcomed the participants to the 36<sup>th</sup> Plenary meeting of the FEEDAP Panel.

### 4. ADOPTION OF THE DRAFT MINUTES OF THE 35<sup>TH</sup> PLENARY MEETING ON 21-22 NOVEMBER 2006

The minutes of the 35<sup>th</sup> plenary meeting of the Scientific Panel held on 21-22 November 2006 were reviewed and adopted.

## 5. WORK PROGRAM

### 5.1. Discussion and possible adoption of the following scientific opinions

- **Safety and efficacy of Selenium enriched yeast (*Saccharomyces cerevisiae*) for all species (EFSA-Q-2005-117)**

A member of the Working Group (WG) introduced the modified draft opinion. This question refers to a feed additive application under Article 4(1) of Regulation (EC) No 1831/2003. The applicant is seeking authorisation of the product Selenium enriched yeast (*Saccharomyces cerevisiae*) to be used as a feed additive for all species (category: nutritional additives; functional group: compounds of trace elements). The new draft was discussed in detail.

The applicant has provided enough evidence to support the efficacy of the product. The Panel also concluded that the safety for the target species has been demonstrated with a margin of safety of seven to ten-fold. The product is also considered safe for the consumers, users and the environment. The Panel recommends that the specification for maximum Se content in the product should be given.

The opinion was adopted after some editorial modifications.

- **Environmental risk assessment: Aquatic compartment (EFSA-Q-2004-079)**

The Rapporteur of the WG introduced the document on the aquatic compartment. After extensive discussion on the sections dealing with the calculation of the Predicted Environmental Concentration (PEC) and its refinement some changes have been introduced.

The opinion was adopted after some editorial modifications.

The terms of reference of this self-tasking activity includes the development of Guidance for the Environmental Risk Assessment of the Terrestrial and Aquatic Compartments, for this reason the publication of this document will take place when both parts will be adopted by the Panel.

### 5.2. Discussion of the following scientific opinions

- **Safety and efficacy of Toyocerin® (*Bacillus cereus*) for sows (EFSA-Q-2006-037)**

- **Safety of Bio-Feed® Pro (proteinase) for chickens for fattening, piglets and pigs for fattening (EFSA-Q-2006-181)**
