DECISION OF THE MANAGEMENT BOARD ON THE WITHDRAWAL OF SOME MEMBERS OF SCIENTIFIC PANELS (AHAW, PLH, NDA) AND THE APPOINTMENT OF A MEMBER OF A SCIENTIFIC PANEL (NDA)

THE MANAGEMENT BOARD OF THE EUROPEAN FOOD SAFETY AUTHORITY,

Having regard to

Regulation (EC) No 178/2002¹ (hereinafter referred to as 'the Regulation') of the European Parliament and the Council of 28 January 2002 laying down the general principles of food law, establishing the European Food Safety Authority and laying down procedures in relation to food safety, and in particular to Article 28(5) thereof,

Decision of the Management Board concerning the establishment and operations of the Scientific Committee, Scientific Panels and of their working groups, and in particular Article 1 thereof²,

Decision of the Executive Director concerning the selection of members of the Scientific Committee, the Scientific Panels, and the selection of external experts to assist EFSA with its scientific work³,

Decision of the Executive Director on Competing Interest Management⁴,

Whereas

- (1) Members of the Scientific Committee or Scientific Panels shall be appointed by the Management Board, acting upon a proposal from the Executive Director, following publication in the Official Journal, in relevant leading scientific publications and on the Authority's website of a call for expressions of interest. The Management Board oversees the correct application of the selection procedure;
- (2) Article 10(3) of Regulation (EU) 2019/1381⁵ of the European Parliament and of the Council of 20 June 2019 on the transparency and sustainability of the EU risk assessment in the food chain and amending Regulations (EC) No 178/2002, (EC) No 1829/2003, (EC) No 1831/2003, (EC) No 2065/2003, (EC) No 1935/2004, (EC) No 1331/2008, (EC) No 1107/2009, (EU) 2015/2283 and Directive 2001/18/EC (hereinafter referred to as 'the Transparency Regulation'), provides that the term of office of the members of the Scientific Committee and of the Scientific Panels who are in office on 30 June 2021 shall be prolonged until the members of that Scientific Committee and those Scientific Panels appointed according to the selection and appointment procedure laid down in point 5 of Article 1 of the Transparency Regulation start their term of office;
- (3) The NDA Panel needs reinforcement following the resignation of one panel member;
