

Assessment of the interests declared pursuant to Article 13(2) of the Rules of Procedure of the EFSA Management Board

The present note provides an assessment on whether the interests newly declared by Board members represent a potential conflict in accordance with EFSA's internal rules and the Board Code of Conduct. Based on this assessment, the Board should reach a conclusion and where appropriate recommend a follow-up.

The following evaluation concerns newly declared interests. The advice takes into account the employment and activities of the member, his/her role in the Board and the responsibilities of the Board in view of the fact that, in terms of impact on EFSA's business, it primarily looks at the regularity and legality of EFSA's processes without entering into the merit of any scientific activity carried out by the other bodies of EFSA.

If an identified conflict that is substantially affecting the work of the Board or EFSA's reputation is not resolved by the proposed assessment and a member of the Board is not fulfilling his/her obligations in relation to independence in such a manner that this is substantially affecting the work of the Board, the Board, acting on a two-thirds majority, may ask for his or her replacement¹.

Assessment: In application of Article 195(f) of the EU Financial Regulations, EFSA invited the organisations represented in the Advisory Forum to show interest in the preparation of the "2022 EFSA's external crisis preparedness exercise", which consists in the organisation

of a workshop aimed at enhancing the collaboration of EFSA with its institutional stakeholders in the area of crisis preparedness and response. EFSA carried out a comparative assessment of the interests received from the Advisory Forum and eventually selected the Bulgarian Risk Assessment Centre on Food Chain (RACFC). RACFC is led by Prof. Georgiev, who covers the role of Director of that organisation. In order to prevent any potential perception of conflict of interest for his double capacity of EFSA Management Board member and Director of RACFC, Prof. Georgiev delegated all powers and accountability for the negotiation of the grant agreement with EFSA and abstained from being engaged in any contractual related step before the signature of the agreement. At the end of the negotiating procedure with EFSA, Prof. Georgiev signed the grant agreement with EFSA in his capacity of legal representative of RACFC. It is noted, in addition, that in order to prevent any further potential perception of conflict of interest, Prof. Georgiev has delegated all powers and accountability with regard to the implementation of the grant agreement. The conclusion of a grant agreement between EFSA and RACFC strictly implements the applicable legal and procedural framework and it cannot constitute a conflict of interest. In addition, in application of Article 8(4) and (7) of the EFSA Management Board Code of Conduct, Prof. Georgiev has applied sensible mitigating measures to prevent any potential perception of conflict of interest.


