## Update of Art. 36 list of organisations operating in the field of EFSA's mission

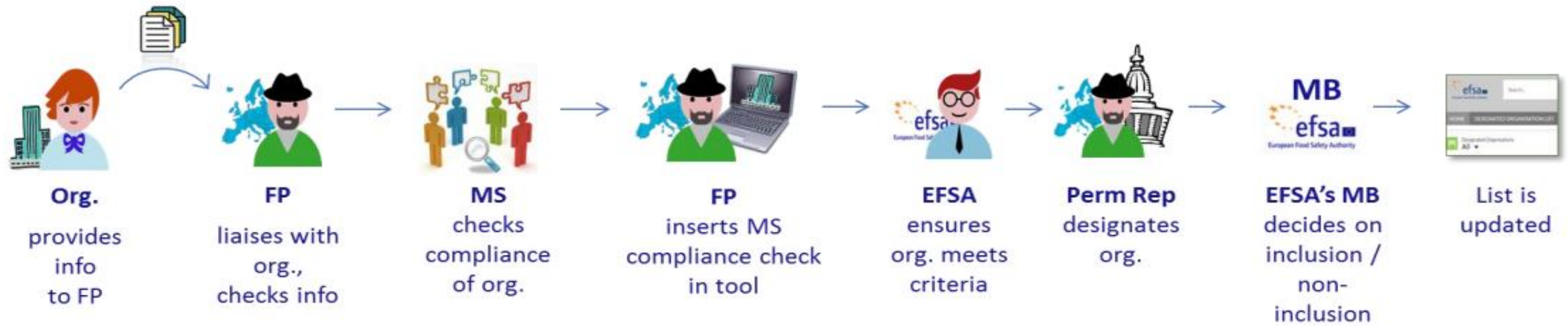
Trusted science for safe food

- **Art.36 of the General Food Law – Regulation (EC) 178/2002:**
  - ✓ EFSA shall promote European networking in fields of its mission and establish a list of **Competent Organisations designated by Member States, which may assist EFSA in its remit**
  
- **Implementing rules - Regulation (EC) 2230/2004 of Art.36:**
  - ✓ establishing the List by approval of EFSA Management Board
  - ✓ specifying criteria of inclusion for MS designations and periodicity of update
  - ✓ indicating usage for EFSA tasks with financial support
  
- **Transparency and sustainability of the EU Risk Assessment in the food chain – Regulation (EU) 2019/1381 amending Regulation 178/2002, Article 1 (5e):**
  - ✓ Gives Art.36 organisations the possibility to prepare scientific opinions for review by EFSA's Panels, in line with greater engagement of MS

**Competent organisations** of the MS need to:

1. carry out **scientific and technical** support **tasks**
2. be **legal entities** pursuing **public interest objectives** and have specific procedures and rules ensuring tasks will be performed with **independence** and **integrity**
3. possess a high level of scientific or technical **expertise** in one or more fields of EFSA's mission
4. have the capacity to operate in a **network** and/or to **perform efficiently the tasks** in the Regulation

# Process of Art.36 List update



## Key roles in the process

- Member States: Organisation / Focal Point / PermRep/Mission to the EU in Brussels
- EFSA: Administrative services / **Management Board**

The Art.36 list must be updated whenever a change occurs to an organisation on the list or in any case at least every 3 yrs.

EFSA provides a tool and database (**CRM**) to collect and share information

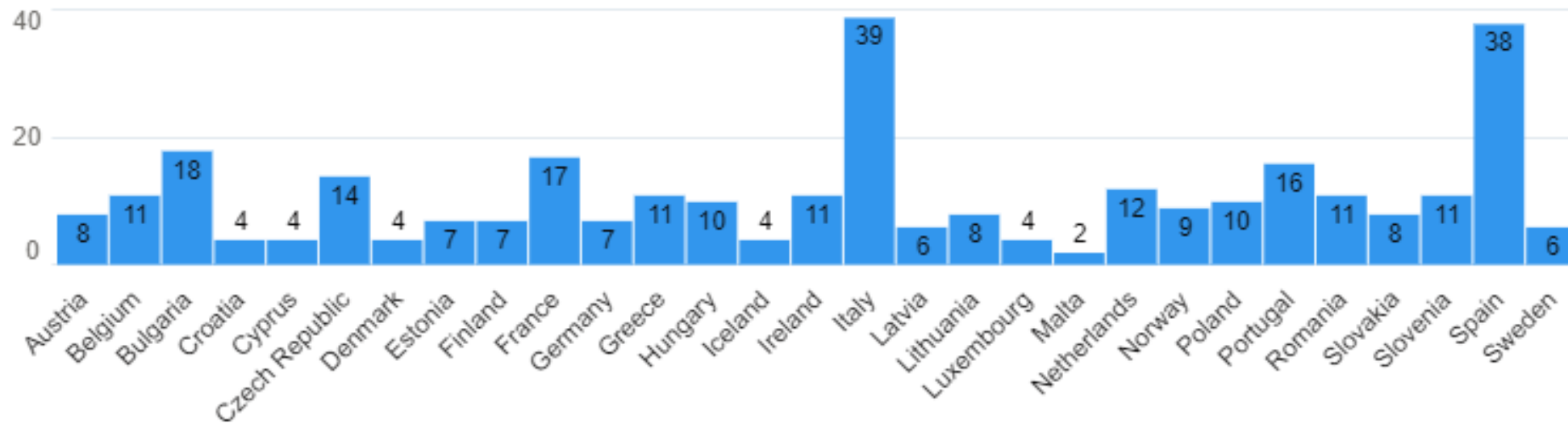

# Current Art.36 List

- Art. 36 List was last **renewed** by EFSA's Management Board on 18 December 2019 and since then has been regularly updated

## For MB approval:

- inclusion in the List of **new** organisations, as designated by MS
- **changes** to organisations already included on the List  
called '*substantial changes*', based on a MS assessment of compliance with the inclusion criteria (e.g. changed legal background or new competencies)

## For MB information:

- **withdrawal** of organisations from the List, removed by MS  
e.g. that no longer exist or meet the inclusion criteria
- **updates** about organisations already on the list  
called '*technical updates*', which provide updated (not '*substantially*' changed) information in line with the previously approved MS designations.



## Article 36 networking

- Pool of EFSA partners in MS eligible for co-operation via **grants / co-financed projects** including entrusting tasks, preparatory work and drafting of EFSA's scientific opinions

- 6 **new** organisations designated for inclusion on the List
- 6 **substantial changes** to organisations already on the List

## For MB information:

- 108 technical updates
- 2 withdrawals
