

Assessment of the interests declared pursuant to Article 13(2) of the Rules of Procedure of the EFSA Management Board

The present note provides an assessment on whether the interests newly declared by Board members represent a potential conflict in accordance with EFSA's internal rules and the Board Code of Conduct. Based on this assessment, the Board should reach a conclusion and where appropriate recommend a follow-up.

The following evaluation concerns newly declared interests. The advice takes into account the employment and activities of the member, his/her role in the Board and the responsibilities of the Board in view of the fact that, in terms of impact on EFSA's business, it primarily looks at the regularity and legality of EFSA's processes without entering into the merit of any scientific activity carried out by the other bodies of EFSA.

If an identified conflict that is substantially affecting the work of the Board or EFSA's reputation is not resolved by the proposed assessment and a member of the Board is not fulfilling his/her obligations in relation to independence in such a manner that this is substantially affecting the work of the Board, the Board, acting on a two-thirds majority, may ask for his or her replacement¹.

Iñaki Eguileor

New declared interests: No new interest was declared compared to the Declaration he submitted in 2019.

Assessment: Complying with the legal requirement demanding to the members of the Management Board to submit an updated DoI on annual basis, Mr Iñaki Eguileor confirmed the interests already declared in 2019. The European University Cyprus is a higher education institution operating in the public interest. The State General Laboratory of Cyprus is a public organisation of the Cypriot Ministry of Health responsible, inter alia, for the surveillance and monitoring of foodstuffs. Through the Cypriot Ministry of Health, State General Laboratory is included among the organisations designated by Cyprus which may assist EFSA with its mission (Article 36 list). The Food Safety Council and the Food Council are bodies of the Cypriot Ministry of Health operating in the public interest. "Better Training for Safer Food" is a training initiative funded by the European Union pursuing capacity building in the food safety area. TAIEX is an institution-building tool of the European Union providing short-term assistance to partner countries.

Current and former activities performed by Ms Ioannou-Kakouri are/were carried out in favour of organisations pursuing the public interest. It is unlikely that these may lead to conflicts, but as a precautionary approach, it is suggested that the Board re-examines their relevance to assess whether specific conflicts may exist when it discusses EFSA's outsourcing programmes.

The Agency for Health and Food Safety (AGES) is a public institution acting in the public interest and it is included among the organisations designated by Austria which may assist EFSA with its mission (Article 36 list). The World Organisation for Animal Health (OIE) is an intergovernmental organisation responsible for improving animal health worldwide. The Global Framework for the Progressive Control of Transboundary Animal Diseases (GF-TADs) is a joint initiative of the Food and Agriculture Organisation of the United Nations (FAO) and of the World Organisation for Animal Health (OIE) pursuing the prevention, detection and control of transboundary animal diseases. The risk management responsibilities Mr Herzog holds at the Austrian Ministry, as well as the managerial roles he holds at the above-mentioned national and international public institutions shall be considered in view of the role exercised by the EFSA Management Board, which by law carries out governance functions without entering into the merit of scientific decision-making processes, the latter pertaining exclusively to the EFSA Scientific Committee and Scientific Panels. It is unlikely that these interests may lead to a conflict of interest. However, as a precautionary approach, it is suggested that the Board re-examines their relevance to assess whether specific conflicts may arise when it discusses EFSA's outsourcing programmes.

However, as a precautionary approach, it is suggested that the Board re-examines their relevance to assess whether specific conflicts may arise when it discusses EFSA's outsourcing programmes.
