

Note to the Management Board

DRAFT PROGRAMMING DOCUMENT 2024-2027 and Expenditures 2024

1. Objective

The following documents are submitted for possible adoption by the Board:

- Final Programming Document 2024-2027, including the final annual work-programme 2024
- Statement of Revenues and Expenditures 2024 (Budget 2024)
- Integration of funds to the EFSA budget 2024 stemming from Horizon Action grant European Partnership on Animal Health & Welfare
- Draft Programming Document 2025-2027, including the draft annual work-programme 2025.

2. Background and Scope

In December 2022, the Board adopted the final Programming Document 2023-2025 and the draft Programming Document 2024-2026, in compliance with the requirements of the Programming Document common template of the EU Agencies. These documents build the multiannual work programme of EFSA in line with its strategic objectives.

During 2023, EFSA prepared the "final draft Programming Document 2024-2026" and the "draft Programming Document 2025-2027" based on the draft Programming Document 2023-2025, and following the European Commission opinion¹ received in June 2023. The draft Programming Documents spanning 2024-2027 reflect the EFSA's multiannual 2024-2027 and the annual plan 2024 and draft annual plan 2025 respectively, in the context of the EFSA Strategy 2027. A list of EFSA replies to the European Commission opinion comments is provided in the Annex 1 below).

As in the past, please note that the two Programming Documents overlap and coincide to a large extent in view of the intersecting timeframe. For a more convenient review, please note that the parts where the two documents differ are:

- The annual work-programmes (section III in each of the two documents and the relevant Appendix B; while Appendix A and C are common)
- The human and financial resources annexes (Annex II to V in each of the two documents)
- The annual grants and procurement work programme (Annex XII in each of the two documents)

Regarding the statement of revenues and expenditures, the structure reflects the one adopted by the Board in December 2022. New expenditure and revenue lines (3240 and 1003

respectively) to accommodate the funds stemming from new ways of EFSA cooperation and partnerships have been added to the budget structure in September 2023, following the 2^{nd} Amending EFSA Budget 2023.

3. Integration of funds stemming from Horizon Action grant - European Partnership on Animal Health & Welfare

In addition to the budget stemming from the European Union and European Free Trade Association (EFTA) contribution (C1 credits) Multiannual Financial Framework, approval is requested for the integration of the funds stemming from EFSA's future participation in the European Partnership on Animal Health & Welfare into EFSA 2024 budget (R0 credits). Under a HORIZON Action Grant, EFSA will become a beneficiary of a grant agreement awarded by the European Research Executive Agency (REA) to a consortium led by the University of Ghent. The grant agreement - to be signed between REA and University of Ghent - will enter into force upon signature by the last party and the project will commence on the 1st day of the month following the month of the signature. Within 30 days following the signature of the grant agreement, EFSA will sign a Consortium agreement with University of Ghent and Accession Annex to the Grant Agreement. The grant agreement provides for a co-financing rate of 50% of the total eligible costs which are estimated for EFSA as € 1.275,991.25. The receipt of 50% co-financing with a total maximum amount estimated at 637,995.63 will be received in 3 tranches over the period of 3 years: a pre-financing payment made within 30 days of the grant agreement signature, followed by an interim payment after 18 months and a final payment at the end of the initial implementation period of 36 months.

4. Next Steps

Following the adoption by the Board of the submitted documents (subject to possible revisions that may be made at the Board's meeting), the next steps in the process are envisaged as follows:

- The Final Programming Document 2024-2026 will be published on EFSA's website and submitted to the EU Institutions by the end of January 2024 and become the reference for guiding EFSA's work programme implementation in 2024.
- The Draft Programming Document 2025-2027 will be further processed as follows:
 - by the end of January 2024: the document will be updated as per the actual 2023 execution data, and submitted to the EU Institutions (i.e. Commission, Parliament and Council);
 - during 2024: the document will be revised to address the opinion that will be received from the Commission and to reflect other important developments that will occur during 2024;
 - by December 2024: the document will be submitted for final adoption to the Board.

1	The Commission welcomes the draft programming document and appreciates that the Authority has addressed the comments included in the Commission Opinion on the programming document 2023-2025.	Noted and appreciated.
2	The Commission highly appreciates the Authority's contribution to the overarching objective of the Union food law, in particular to maintain a high level of protection of human health and consumers' interests in relation to food, including but not limited to food and feed safety, while addressing animal health and welfare as well as plant health within the Union. 3	The Commission notes that the draft programming document reflects the Union's priorities in the areas falling under the Authority's remit and 'EFSA Strategy 2027 and welcomes the flexibility the Authority is demonstrating to respond to evolving requirements.	Noted and appreciated.
4	The Commission invites the Authority to continue prioritising its support to the Union's activities on food and feed safety addressing biological and chemical hazards, animal health and welfare, plant health, and other aspects including those relating to the area of regulated products, where legal deadlines apply (core risk assessment activities). The Commission underlines that the tasks needed to enable the Commission to fulfil its legal obligations, as well as any other tasks requiring urgent action, should take priority over other tasks.	EFSA will continue prioritising its core tasks over other activities, i.e. responding to requests from its customers for scientific advice, and within them prioritisation will be made on the basis of legal deadlines, and for addressing requests for urgent action, to enable the risk managers to fulfil legal obligations. EFSA will do so safeguarding the minimum investment necessary for continuous improvement and development initiatives to ensure, in line with EFSA strategy, that it remains relevant and prepared in the medium to long term.
5	The Commission acknowledges the Authority's high workload and appreciates that the Authority commits to further prioritise its core risk assessment activities, without downsizing or discontinuation of already mandated tasks. The Commission welcomes that the Authority has planned various measures to address the high workload (e.g. increased outsourcing of the scientific preparatory work to the designated national scientific organisations referred to in Article 36 of	Further detail has been given throughout the document on the specific actions taken for each of the critical scientific production areas (supporting the information provided in table 20-now table 2). EFSA would like to highlight that the actual number of the stock of questions (backlogs) per each scientific area will be reported in the upcoming Annual Activity Report 2023.

	Regulation (EC) No 178/2002, on-going fine tuning of the information technologies (IT) systems supporting the risk assessment process, and increased scientific production delivery by reducing the human resources investment in development activities to a maximum of 10% of the Authority staff). The Commission also notes the specific actions taken for each of the critical scientific production areas (Table 20 of the programming document) and invites the Authority to describe those in more detail, including information on the actual number of the stock of questions (backlogs) per each scientific area.	
6	The Commission is nevertheless concerned that the stock of questions in the areas of regulated products remains high and it does not seem to decrease at a considerable rate. The Commission notes that the Authority foresees a progressive reduction of the stock of questions – at least in some critical areas – from 2023 onwards and to a level equivalent to one year production by 2026-2027. However, these estimations for the forecasted evolution of stock for the period 2023-2027 are based on several assumptions, including in particular on ensuring successful partnerships and synergies with the national scientific organisations.	Indeed, the forecasted evolution of stock relies on several assumptions, in particular EFSA's ability to implement structural measures, such as the development of partnerships with art.36 organisations. To achieve this, considerable resources have been allocated for seeking opportunities for collaboration and establishing partnerships, supported by outsourcing methodologies. To this end, EFSA has held joint workshops with DG SANTE, and has carried out a number of initiatives over 2023 to identify opportunities for increasing the speed of risk assessment and production output. Follow-up actions will start to be implemented as of 2024 onwards.
7	The Commission supports the Authority's engagement to further cooperate with the Member States and recognises the challenges relating to building partnerships with national scientific organisations to carry out preparatory work to support the tasks of the Authority's Scientific Committee and Scientific Panels. In this respect, the Commission would like to invite the Authority to carefully consider the areas of work to be outsourced, taking into account the available capacity and expertise at national level. Development of partnerships with national scientific organisations is a long-term objective which would need, in most of the areas, considerable investment from the Authority to ensure that the outsourced work is performed according to the Authority's methods and quality standards. Accordingly, the Commission invites the Authority to consider taking mitigating measures for advancing its risk assessment work, while preparing the ground for effective partnerships with the national scientific organisations. Additional information on the selection and planning of the outsourced activities in the programming document would also be welcomed.	EFSA is placing due emphasis on the selection and planning of areas of work to be outsourced, considering the needs as well as the capacity if Member States to respond; indeed this has proven to be a resource intensive activity, including the involvement of the EFSA Advisory Forum to steer the process. A recent example is the recently signed four-year (2023-2026) Partnership with Member State Article 36 organizations to provide support to EFSA in the risk assessment of food additives, food enzymes, food flavourings and feed additives. EFSA will ensure that the outsourced work is performed according to its methods and quality standards by promoting organisational capacity building and delivering training to Art. 36 organisations while enhancing the support role provided by the Focal Point network (on the basis of new Focal Point operational framework) and continuing the EU-FORA programme.

•	8	The Commission acknowledges the Authority's need for safeguarding the minimum investment necessary for continuous improvement and development initiatives. The Commission welcomes the Authority's decision to reduce the human resources investment in development activities (to a maximum of the 10% of the Agency staff), which would allow the scientific units staff currently involved in development activities to focus more on risk assessment "Business As Usual" activities. In a context of limited resources and taking into account the high number of stock of questions, the Commission invites the Authority to continue assessing all its development activities and to prioritise those that are expected to have an actual positive impact on the Authority's "Business As Usual" work either in speeding up the risk assessment process or in terms of addressing short- and medium-term risk assessment needs. The Commission welcomes that any deprioritisation of development activities would be managed in liaison with the Commission.	Noted and appreciated.

12	Scientific knowledge and availability of data continue to evolve rapidly and the Commission acknowledges the challenges linked to the new developments in risk assessment. The Commission takes note of the Authority's work on process improvement initiatives including guidance development and review which should aim to ensure both the robustness and efficiency of risk assessment. In this context, the Commission calls the Authority, in particular in the area of generic risk assessments, to ensure flexibility in the application of guidance documents and focus on fit-for purpose risk assessments. The Commission welcomes that the Authority lists a number of guidance documents that need to be updated and that it considers the development of a multi-annual plan for guidances' updates in liaison with the Commission.	EFSA acknowledges the Commission comments, and reassures that a flexible approach regarding the application of guidance documents in the generic risk assessments area is being and will continue to be employed. EFSA's aim is to always deliver fit-for purpose risk assessments. The Commission also notes that three new programmes (i.e. DEEP, IRMA and NEXT) will manage the Authority's projects aimed at improving and developing the core business through the three strategic transformation priorities: (1) speed of risk assessment; (2) preparedness for future risk assessment needs; and, (3) digital collaboration within the Union food safety system. In this respect, while the Commission appreciates the information already provided in Appendix B to the programming document, it invites the Authority to specify, where relevant, the expected contribution of these projects to address short- and medium-term risk assessment needs or other risk assessment activities (e.g. the 'Business As Usual' work, the reduction of stock of questions, etc.). EFSA considered the European Commission's advice of analysing if the position could be shared with another Union Agency. However, due to the very specific tasks/issues EFSA deals with and the volume of work it entails for the size and breadth of activities, it has been assessed that there is no scope for sharing a resource for this cybersecurity position. Still, EFSA is investigating into other means of possible collaboration with other agencies in the field of converged security.
3	Grading: There is an excessive amount of AST staff in the establishment plan of EFSA; the Commission invites the Authority to solve this issue and comply with the agreed distribution of AD and AST TA staff.	The EFSA's request for Establishment Plan envisages a gradual conversion of AST posts into AD posts with the aim to reduce its share of Support Staff. On this regard several initiatives of project/process improvements have been put in place to achieve efficiency gains as well as leading to the outsourcing of some services freeing up internal FTEs mainly pertaining to the assistant category. Staff turnover and/or outcome of internal procedures are the pre-requisite for freeing up AST positions to be then upgraded into AD ones. In fact, in 2023 two AST posts were freed up and upgraded into AD posts and the EFSA's plan is to follow this pattern for as many positions as possible in the coming years to comply with the Establishment Plan post distribution.
3	Reclassification: The Commission would like to stress again that the Authority should follow more closely the seniority in grade stated in Annex IB of the Staff Regulations. The Commission requires that this issue is now seriously tackled and followed up.	EFSA has been steadily increasing its promotion rate over the years: from 13.5% in 2020 to 18.9% in 2023. While Annex IB is always kept as reference, to entirely align with the indicative durations therein described, EFSA needs to follow a constant, gradual and incremental pathway to reach an approximate 30% promotion rate. To accommodate an increased promotion rate, additional elements also need to be taken into consideration and balanced: A significant adjustment of our Establishment Plan projections would be needed within the framework the next planning cycle (2025-2027);

		 The cumulative financial impact of this increase would be significant - staff costs will absorb up to 42% of EFSA's total budget in 2023; In particular with reference to high grades, the distribution of our population would be significantly skewed towards higher grades (~50% in grades AD9 and above) over the next 5-10 years, also considering the very limited turnover rate of the organisation.
		EFSA's promotion/reclassification exercise strictly follows the Implementing Rules on the reclassification of Temporary Agents: every year, Reporting Officers compare merits of their eligible staff and write a business case for promotion/reclassification. The business cases and relevant merits are further discussed and compared at unit, department and organisational level; this latest comparison takes place with EFSA's senior management and results in the 1st draft list for promotion/reclassification which is subsequently presented and discussed with a delegation of EFSA's Staff Committee, resulting in the 2nd draft list published and available to all staff.
		It must be noted that staff engagement index is at 79%, a key leading indicator that staff appreciates the organisational approach to talent management, including broader means of recognition and development (e.g., via participation to programs and projects, mentoring, job rotation, job shadowing, training, a dedicated leadership development program).
32	Gender and geographical balance: The Commission considers that more attention is to be paid to the gender and geographical balance dimensions. The Commission recommends the Authority to present at least once a year the data on these dimensions and its evolution over years to the Management board supported by the proactive actions in place to mitigate the current situation.	EFSA takes note of the suggestion of the European Commission. In the progress report to the Management Board EFSA will provide an update on the evolution of the gender and geographical balance combined with a summary of our actions. The following initiatives are part of a comprehensive employer branding strategy focusing on increasing the visibility of EFSA as an employer with the support of its Communication and Partnership Departmenttargeted initiatives to increase EFSA's attractiveness and the nationality balance have been promoted such as extra dissemination efforts on social media platforms, targeted dissemination in certain Member States and participating/organising career events in all EU Member States. EFSA has also reached out to other EU Agencies on best practices to attract diverse candidates as well as with its Partner Organisations (more in particular EFSA's Focal Points) in the different EU Member States to reinforce the collaboration, by providing with them with new communication material and to discuss joint career eventsa new career website was launched in May 2023 with new creative and

Annex 2: Integration of funds stemming from Horizon Action grant - European Partnership on Animal Health & Welfare

Detailed information

Under Europe's Research and Innovation funding programme 2021 – 2027, a new instrument - the European Partnerships - was established.

The European Partnership Animal Health & Welfare (EUP AH&W) aims to deliver key knowledge, services and deliverables to significantly improve the control of animal infectious diseases and animal welfare in a coordinated way. EFSA's contribution to this partnership aims to bridge possible gaps between research and regulatory science and facilitates the use of the outcomes of this research programme for regulatory science needs.

For EFSA, it will facilitate the science-to-policy transition, supporting the implementation of EFSA's roadmap on animal welfare, expand the One Health approach, collect missing data and complement the existing EFSA Networks, linking them to networks of other research organisations. It will allow quicker uptake of scientific data and methodologies produced by academia into EFSA's risk assessment work and creates the opportunity to follow up on research recommendations stipulated in EFSA opinions and the upcoming SPIDO roadmap on animal welfare.

EFSA will contribute via support to the identification of research needs, the design and development of guidelines and surveillance strategies and the identification and validation of methods. EFSA's expertise will be instrumental to EUP-AH&W in the establishment of an assessment protocol, design of the data model, data tools and data platform to ensure compatibility with existing systems.

The most relevant involvement for EFSA is in Work Packages 2 (SRIA update & Monitoring) and 3 (Joint initiatives & integration) to ensure that the EUP-AH&W outputs will be of use and do not duplicate EFSA actions.

EFSA will be involved as a full partner (i.e. beneficiary receiving grant funding). This is the best way to ensure synergies with risk assessments done by Member States and EFSA and to avoid duplication of activities and double funding. DG-RTD and DG AGRI have expressed on several occasions the need for close alignment of EFSA and eventually other EU Agencies such as the European Medicines Agency (EMA) in the EUP-AH&W to avoid diverging scientific opinions/outputs and avoid duplication of activities.

DG SANTE agreed with EFSA's involvement, allowing it to participate in the call HORIZON-CL6-2023-FARM2FORK-01-2. SANTE's agreement is without prejudice to the analysis to be carried out on double funding, for which beneficiaries are asked to declare the absence of double funding. In addition, the Research Executive Agency (REA) runs specific searches retrospectively verifying there is no double funding of the same activity.

The grant agreement - to be signed between REA and University of Ghent - will enter into force as of its signature of by the last party and the project will commence on the 1st day of the month following the month of the signature. Within 30 days following the signature of the grant agreement, EFSA will sign a Consortium agreement with University of Ghent and Accession Annex to the Grant Agreement.

Resources

The alignment of the activities will have to be performed by staff with an in-depth understanding of the ongoing and planned EFSA work.

Note to the Management Board GPS/EMPOWER



EFSA estimates to dedicate around 1 FTE (Full Time Equivalent) of its current workforce to the overall coordination and planning activities of EUP-AH&W, including senior staff from Biological Hazards and Animal Welfare Unit (acting as liaison for their specific domain of expertise and involvement in ongoing EFSA's mandates), Finance and Chief Scientist's Office (providing administrative and financial support to administer the grant agreement, e.g. receive the funding, recording and reporting effort to evidence the costs incurred).

EFSA will hire 2 contract agents to perform tasks directly linked to Partnership implementation, paid from the EUP-AH&W grant that does not weigh on the establishment plan and contract agents' posts ceiling.
