

## Mrs Catherine Geslain-Lanéelle - Vice-Chair, EFSA Management Board

Mrs Catherine Geslain-Lanéelle is Regional and Interdepartmental Director for Agriculture and Forests for Ile de France at the French Ministry for Agriculture, Food, Fishing and Rural Affairs. She holds degrees from the Institut National Agronomique Paris-Grignon, from the Ecole Nationale du Génie Rural des Eaux et des Forêts and from

Paris II. From 1991 to 1993, she worked for the European Commission in the area of risk management and risk assessment. She has widespread experience of serving on Councils and Committees, often in the capacity of chair. She is currently chair of the Codex Alimentarius Committee on General Principles.



#### Professor Ortwin Renn – Department of Social Sciences, Stuttgart University, Germany

Professor Ortwin Renn is currently Director of the non-profit company DIALOGIK, a research institute for the investigation of communication and participation processes in environmental policy making and full Professor and Chair of Environmental Sociology at the State University in

Stuttgart (Germany). He holds a Diploma in sociology, economics and journalism and a Ph.D. in social psychology. He is a Fellow of the American Association for the Advancement of Science (AAAS) and the Society for Risk Analysis (SRA). Professor Ortwin Renn is also a Member of the panel on "citizen participation" of the U.S. National Academy of Sciences in Washington, D.C. and an ordinary member of the Berlin-Brandenburg Academy of Sciences and of the European Academy of Science and Arts. He is Chair of the German Federal Committee on the Harmonization of Risk Standards, the Scientific Advisory Board of the Foundation "Precautionary Risk Management," and the State's Scientific Committee for Environmental Research.



#### Professor Lynn Frewer - Research Professor, Food Safety and Consumer Behaviour Marketing and Consumer Behaviour Group, University of Wageningen, The Netherlands

Professor Lynn Frewer occupies the Research Chair in Food Safety and Consumer Behaviour at the University of Wageningen in the Netherlands. Previously Professor Lynn Frewer was head of Consumer Science

at the Institute of Food Research in Norwich in the UK. She has research interests in multidisciplinary activities associated with understanding public responses to food risk issues, consumer confidence in food risk analysis, identifying the determinants of consumer food choices, and developing effective mechanisms for conducting and evaluating public consultation regarding food safety practices. Professor Lynn Frewer has extensive contacts with the policy community and agro-food industry through formal and informal networks, including membership of EU thematic networks, integrated projects, and concerted actions, close liaison with the international NGO community, and involvement in knowledge transfer activities with industry and other end users.



## Mr Geoffrey Podger – Executive Director, EFSA

Mr Geoffrey Podger was Chief Executive of the UK Food Standards Agency since its inception in 2000. Prior to this, he worked for the UK Department of Health for 18 years from 1982. Before taking up responsibilities in the food area, he was Under-Secretary for Health Promotion. He also headed the Combined Joint Food

Safety and Standards Group of the Department of Health and the Ministry of Agriculture Fisheries and Food from its launch in 1997. He has considerable experience in the management of matters involving the interface of science and policy and has strongly promoted transparency and openness as key principles in effectively addressing difficult food safety issues. Mr Geoffrey Podger was appointed as Executive Director of EFSA by the Management Board on 2 December 2002 and took up his position on 1 February 2003.



#### Mr Paddy Coulter - Director, Reuters Foundation Programme, Green College, University of Oxford, UK

Mr Paddy Coulter is Director of the Reuters Foundation Programme for international journalists at Oxford University. He is a Fellow of Green College and an Associate Fellow of the University's Environmental Change Institute. He previously worked (between 1990 and 2001) as Director of

the International Broadcasting Trust (IBT), an independent television production company specialising in programmes on global affairs for BBC, ITV, Channel 4 and leading broadcasters around the world, where he commissioned and produced more than 100 television programmes on international issues. He was Head of Communications at Oxfam from 1982-1987 and received an award in the January 2000 British Honours List for his services to development awareness.



#### Mr Alan Reilly - Food Safety Authority of Ireland

Mr Alan Reilly is Deputy Chief Executive of the FSAI and Director of two of the FSAI's Divisions - Food Science and Standards, and Consumer Protection. He has over 30 years experience working in food safety and joined the FSAI in 1999. Before joining the Authority, Mr Alan Reilly worked in the Food Safety Programme of the World

Health Organization in Geneva. He has spent a number of years in the UK scientific civil service and has worked as a visiting associate professor at the College of Fisheries, University of the Philippines. A chartered biologist, Mr Alan Reilly holds a BSc from University College, Dublin and a Master of Technology degree from Brunel University in Uxbridge, UK. He is a member of the Advisory Forum of the European Food Safety Authority and a member of the Scientific Advisory Board of the European Food Information Council. He also acts as a food safety advisor to the World Health Organization, the UN Food and Agriculture Organization and the International Foundation for Science.



Professor Peter Biacs - Director, Hungarian National Food Agency

Prof. Dr. Peter Biacs is General Director of the Hungarian National Food Agency. His main areas of interest lie in chemical engineering, food engineering and biotechnology, food chemistry, lipid chemistry and analysis, industrial microbiology and enzymology, yeast and moulds, food law and regulation. Before

being appointed General Director, Prof. Dr. Peter Biacs held the position of Deputy State Secretary at the Ministry of Agriculture and Regional Development with responsibility for food safety and consumer affairs. He holds a B.Sc., M.Sc., Dr.tech., and Ph.D. in Chemical Engineering from the Technical University in Budapest and a D.Sc. in Food Chemistry and Biotechnology from the Hungarian Academy of Sciences. The main task of the Hungarian National Food Agency is to coordinate the activities of the Hungarian authorities involved in food and feed control in Hungary. It is an independent institution directed by a Steering Committee of 5 members.



Caroline Smith DeWaal - Food Safety Director, Center for Science in the Public Interest, United States Mrs Caroline Smith DeWaal is the director of the food safety programme for the Center for Science in the Public Interest (CSPI) and co-author of Is Our Food Safe? A Consumer's Guide to Protecting Your Health and the Environment (Three Rivers Press, 2002). She represents

CSPI in Congress and in the regulatory arena on such issues as meat and poultry safety, seafood safety, food additives, pesticides and sustainable agriculture, and animal drugs. Mrs Caroline Smith DeWaal is the leading consumer analyst on reform of laws and regulations governing food safety. Since 1999, she has maintained and annually published a listing of foodborne illness outbreaks organised by food source that now contains over ten years of outbreaks reports. The Center for Science in the Public Interest is a consumer advocacy organisation whose twin missions are to conduct innovative research and advocacy programmes in health and nutrition, and to provide consumers with current, useful information about their health and well-being.

#### **BEUC**

Since 1962, BEUC the European Consumers' Organisation, has been based in Brussels, at the centre of the European policy and decision making process. They represent the interests of 38 independent national consumer organisations from 28 European countries to the European Institutions. Their aim is to defend the interests of European consumers in the EU policy process. They contribute expertise on issues that have direct economic or legal consequences for consumers or that impact consumers' health, safety and environment.

#### CIAA

The mission of the CIAA (Confederation of the food and drink industries of the EU) is to help pro-actively develop an environment (enlarged EU and global markets) in which all European food and drink companies (whatever their size) can compete effectively for sustainable growth, meeting the needs of the consumers and playing their part in achieving the targets set by the Lisbon declaration.
