4.1 Protection Goals ([EFSA-Q-2013-00289](#))

The working group (WG) addressed the comments received from the Commission, in particular in relation to the dialogue between risk managers and risk assessors when defining specific protection goals in the problem formulation phase of the environmental risk assessment. It was decided to expand section 1.3. of the document by explaining in greater detail the aim of the document, the respective role of risk managers and risk assessors, and the way the proposed framework is applicable to all potential stressors within EFSA's remit, also in non-pristine environments in which biodiversity is impacted by anthropogenic activities. It was also decided to describe in section 1.6 (or in a new section 1.7), in greater detail, the relation between biodiversity and ecosystem services in an agricultural context. In addition, it was decided that the provided SPG examples need a better introduction by explaining their aim and scope, which is the provision of possible SPG options by risk assessors of EFSA on the basis of the framework provided in the document and that may serve as starting point for the dialogue between risk assessors and risk managers. Several WG members suggested placing the SPG examples in an Appendix. The challenges and recommendations section was also discussed and amended.

It was decided to add extra information to the GMO Laurel forest example to make clear that the introduction of cold-tolerant Eucalyptus is a potential realistic problem for Macaronesia and not merely a hypothetical exercise.

The conclusion and challenges sections were also discussed. It was decided to re-elaborate the challenges section by also introducing recommendations for each identified challenge. The document was considered ready for the reading and discussion at the forthcoming plenary of the Scientific Committee (17th February).

The issue of whether habitat can be considered as an ecological entity or whether it is intrinsically covered by protecting populations or communities was extensively debated. Also the issue of its operationalization within the ERA procedure was considered. In addition, concerns were raised whether "sustainability of agricultural systems" and "landscape structure" are attributes of the SPG that can be operationalized in prospective ERA schemes for regulated products like PPPs, feed additives and GMOs.

It was decided to hold an additional working group meeting in order to further debate on the remaining issues. Because of the need for further discussion, the Guidance will not be presented at the Scientific Committee plenary session scheduled on 11-12 November but rather in the February 2016 plenary session.

5.1 Endangered Species ([EFSA-Q-2013-00901](#))

147 comments were received from the public consultation and the consultation with the RA agencies. All Sections of the opinion received comments. Recurrent and high impact comments were first discussed in their general context and then answered case-by-case. Each individual comment was answered and amendments were made to the draft scientific opinion as appropriate. All comments were considered constructive and contributed to refinements of the draft opinion. The meeting time was extended by having an additional 2 hour teleconference on 16 October, in order for the experts to read-through the final draft of the opinion.

Some general comments were pointing towards the need for holistic approaches to environmental risk assessments. In general, the 3 ERA documents are perceived as a step in the right direction, but still on single-stressor risk assessments. Since EFSA operates in its current legal framework, some comments about multiple stressors could not be fully taken into account.

The level of impaired viability of the population of endangered species is a fundamental data input before starting ERA. However, such data are very often only available at local scale. Also the definition of endangered species, chosen as a working definition for this opinion, will remain scale-dependent.

5.1 Protection Goals ([EFSA-Q-2013-00289](#))

The working group members started discussing outstanding issues, amendments and comments related with the core sections of the opinion. Then the discussion focused on restructuring, particularly the possibility of concentrating on the assessment endpoint level of the problem formulation and move the other parts to the Annexes. The members proposed to use the six dimensions for each ecosystem service/key driver combination as assessment endpoints and to summarise the links with the other parts of the problem formulation, analysis and risk management phase. Moreover the members proposed to draft criteria for the selection of the most appropriate option for each dimension. Given the impact of this proposal, it was discussed with the whole group on 5 September where it was decided to elaborate the proposal. This discussion continued on per teleconference on 15 September. The next WG meeting will focus on the discussion of these criteria and on the new structure of the opinion.

5.2 Recovery ([EFSA-Q-2013-00902](#))

The working group members have thoroughly revised the first three sections of the scientific opinion (i.e. 1. Introduction, 2. Ecological recovery in the prospective environmental risk assessment for regulated stressors and 3. Pulse and press disturbance and ecological recovery and clarification on terminology). The members have discussed in good details the conceptual framework for the assessment of ecological recovery in prospective ERAs for regulated products. This framework was further elaborated and presented to the whole ERA WG on 5 September for discussion. New actions were identified for each member for the revision and implementation of sections 5 to 9 to be partly covered by 17 October (section 5-8) and 20-21 November (section 9).

5.3 Endangered Species ([EFSA-Q-2013-00901](#))

The experts have collected information relevant for the assessment of the risks for endangered species caused by regulated stressors to the food/feed chain. This process will continue by including further Panel specific information. As intermediate conclusions are being considered, a restructuring of the document was suggested to better rankorder and frame the key issues. The positioning of the present parts and how they should be reworked was discussed. EFSA staff will prepare the updated document and circulated the task distribution for delivery by the next teleconference on 9-10 October. Given the impact of these changes, an extra meeting has been scheduled for 3-4 November.

5.4 Joint session on all 3 questions

The 19th Scientific Colloquium on "*Biodiversity as protection goal in environmental risk Assessment for EU agro-ecosystems*" took place on 27-28 November 2013. Nearly 100 scientific experts from various stakeholder groups participated and exchanged ideas on protection goals in ERA for agro-ecosystems, specifically on measuring biodiversity, on covering endangered species and on the ecological recovery concept. The discussions at the Colloquium, represent an important source of information for the working group aiming at harmonisation of making protection goals operational in ERA. The WG discussed further the elements and steps underlying the operationalisation of protection goals as mentioned in broad terms in the law. Similarities and differences are identifiable in the current ERA schemes in EFSA and careful evaluation is required of where harmonisation would be useful, and where not. This process will benefit from further illustrations and details to be presented at the next working group meeting. One common glossary was acknowledged as essential.

5.2 Endangered Species ([EFSA-Q-2013-00901](#))

Key issues regarding the coverage of endangered species in current ERA schemes were discussed in the context of developing the opinion under the ERA mandate and the above question number. A first outline was proposed to address the specific questions of the terms of reference.

In accordance with EFSA's Policy on Independence and Scientific Decision-Making Processes¹ and the Decision of the Executive Director implementing this Policy regarding Declarations of Interests², EFSA screened the Annual Declaration of Interest and the Specific Declaration of interest filled in by the experts invited for the present meeting. No conflicts of interests related to the issues discussed in this meeting have been identified during the screening process or at the Oral Declaration of Interest at the beginning of this meeting.

4. Background information

Tasks and deliverables of the WG:

As specified in the mandate, the Working Group shall provide separate draft opinions on harmonising the approach to setting protection goals and the two specific elements of environmental risk assessment (ERA) within the remit of EFSA, i.e. Coverage of endangered non-target species and Recovery of non-target species. The approved mandate as well as the letter of acceptance is available in the EFSA public register of questions [EFSA-Q-2013-00289](#) and on sciencenet. The draft opinions should be presented to the EFSA Scientific Committee for possible adoption by June 2015.

Composition of the WG:

As specified in the mandate, Experts from the relevant EFSA Panels (GMO, PPR, PLH and FEEDAP) are included in the working group. An additional expert member was selected on the basis of his complementary expertise for ecology of a wide range of non-target arthropods.

In accordance to the mandate, the working group will involve during the preparation of the opinions the experience and guidance developed by other EU agencies and scientific bodies through the presence of the observers from the European Environmental Agency (EEA), European Chemicals Agency (ECHA), European Medicines Agency (EMA) and OECD. Nominations are awaited from JRC and the DG SANCO non-food committees, especially the Scientific Committee for Environmental Health Risks. The US Environmental Protection Agency has nominated an expert for the colloquium. WHO/IPCS did not yet respond.

Agreed work division:

The overarching SC ERA WG will ensure consistency throughout the mandate and will ensure that all activities are developed in a way that is compatible for all the relevant EFSA panels. This overarching WG is advising on the topics of the colloquium on protection goals (see item 5.1). In addition topical meetings will be organised for endangered species and for recovery. The overarching WG will meet 2-3 times per year and topical meetings might be organised up to 4 times a year.

5. Scientific topic(s) to be addressed in the opinions

During an upfront survey amongst the WG members, there seems not to be prior work done in this area by other scientific risk assessment bodies at European level. Aspects and required expertise of relevance, for inclusion in the work were discussed.

5.1 Protection Goals ([EFSA-Q-2013-00289](#))

After the introduction by Robert Luttik, discussions took place in the context of organising a Scientific Colloquium on the topic of protection goals on 27-28 November in Parma. The same themes will be addressed as during the EFSA 2010 workshop³ on PPP. Now, the aim is to have more wide discussions regardless of the type of stressor.

5.2 Endangered species ([EFSA-Q-2013-00289](#))

The context and current state of the art were presented by Robert Luttik during a short introduction of this specific topic. The WG members shared general views and initiated discussions on the more specific questions under the mandate:

- *“Are endangered species more vulnerable than other species:
 - based on their toxicological sensitivity, exposure, specific potential for recovery, low genetic diversity, or
 - because of other stressors e.g. limited, marginal or fragmented habitat?*
- *Do the current ERA schemes appropriately cover endangered species?*
- *If not, what risk mitigation measures can be envisaged to prevent endangered species being put at risk from stressors resulting from the application of a regulated product?*
- *Is monitoring needed to check the efficacy of risk mitigation measures for the occurrence of endangered species?”*

The WG will focus on developing a method for assessing the risk to endangered species. The context of this work is the risk assessment of regulated products to be used in agro-ecosystems. The question if endangered species can/should be protected in agricultural fields is a broader question extending beyond the remit of this WG.

5.3 Recovery ([EFSA-Q-2013-00289](#))

Also for this topic, the context and current state of the art were presented by Robert Luttik during a short introduction. The WG members shared again their general views and experience. Discussions were initiated on particular aspects of relevance, in order to prepare for answering the specific questions of the mandate:

- *“Which are the relevant traits of different organism groups and what are their respective quantifiable and/or non quantifiable parameters that characterise recovery, e.g.*
 - *genetic diversity, needed for populations to adapt to new selective pressures of the environment,*
 - *potential for internal recovery by the exposed population, determined by life-cycle and reproduction characteristics,*
 - *potential for external recovery (immigration) from unexposed populations, determined by dispersion ability and mobility.*
- *How to take into account the potential of recovery in ERA under real field conditions assuming repeated exposure? The above traits of different organism groups relevant for recovery could be used for comparison to e.g. the pesticide application patterns or other exposure patterns relevant for other units of EFSA.*
- *How to describe the parameters relevant for the recovery of different organism groups in a generic way i.e. which would allow their use in other (or all) relevant areas within EFSA’s remit.”*

6.2 Special remarks

The ongoing work of the PPR WG on good modelling practice might inform this mandate.
